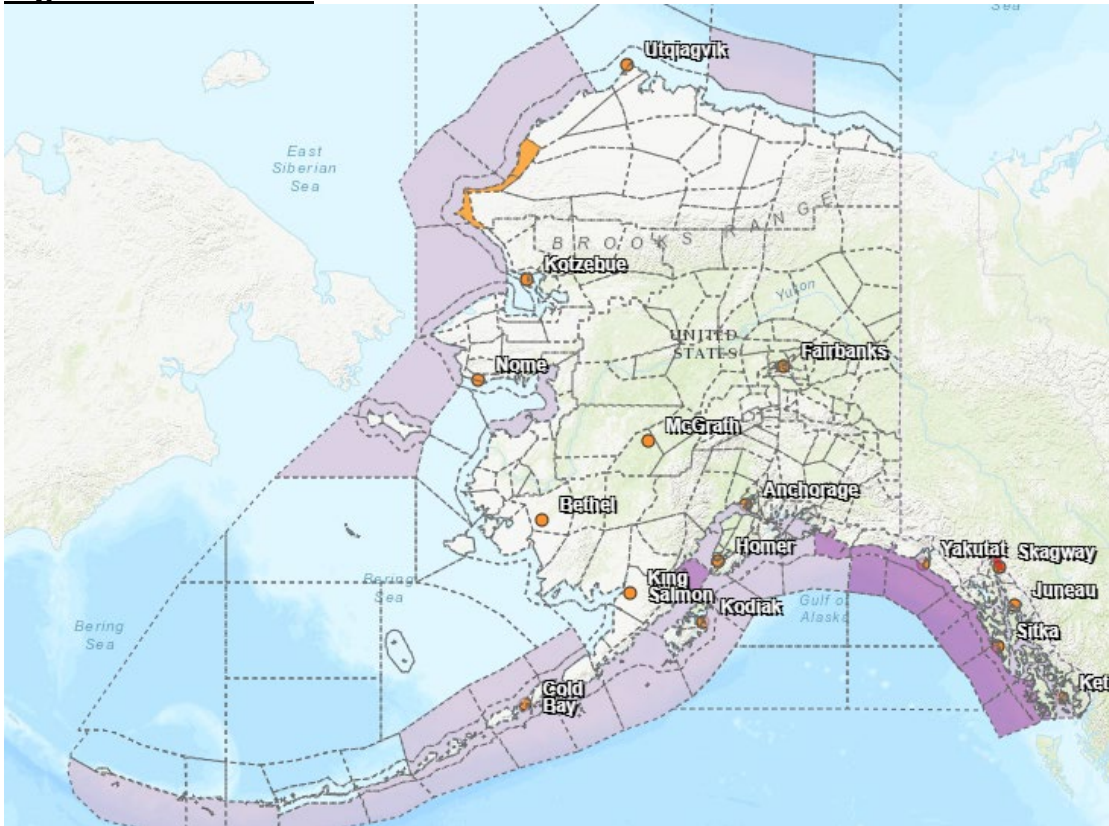

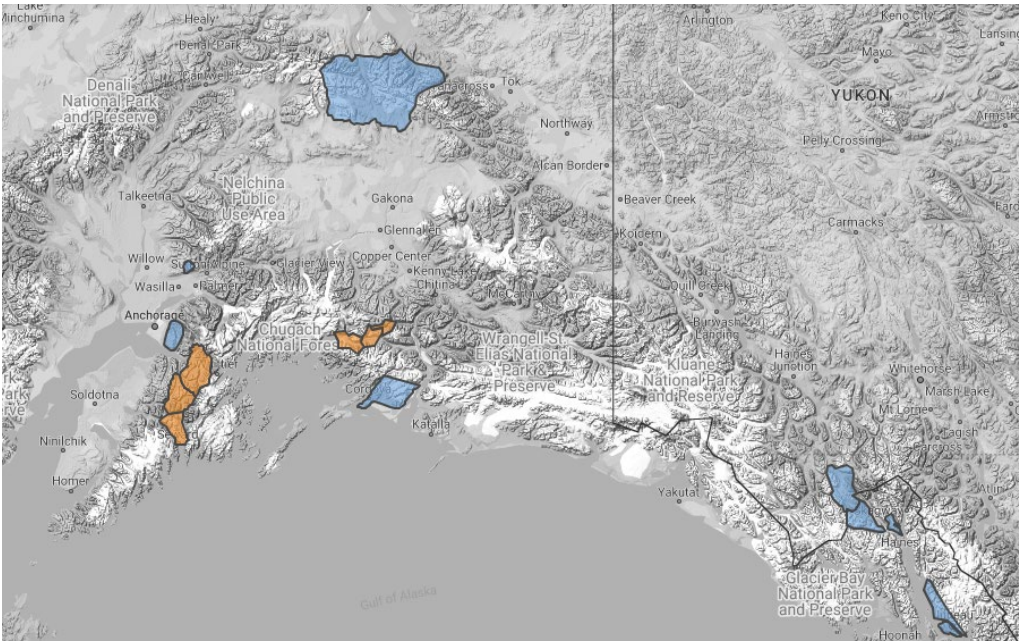

Valdez Maritime, Intermountain, and Continental – Considerable above 1500', Considerable above 3000'

Hatcher Pass –Low at all levels.
