


# **Significant Weather:**

Turnagain Pass – Moderate below 1,000', Considerable Above 1,000' Summit Lake – Low below 1,000', Moderate Above 1,000' Seward and Lost Lake – Considerable Above 1,500', Moderate below 1,000' Valdez Maritime Intermountain Continental – Moderate at below 1,500 and above Hatcher Pass –Low at all levels.
