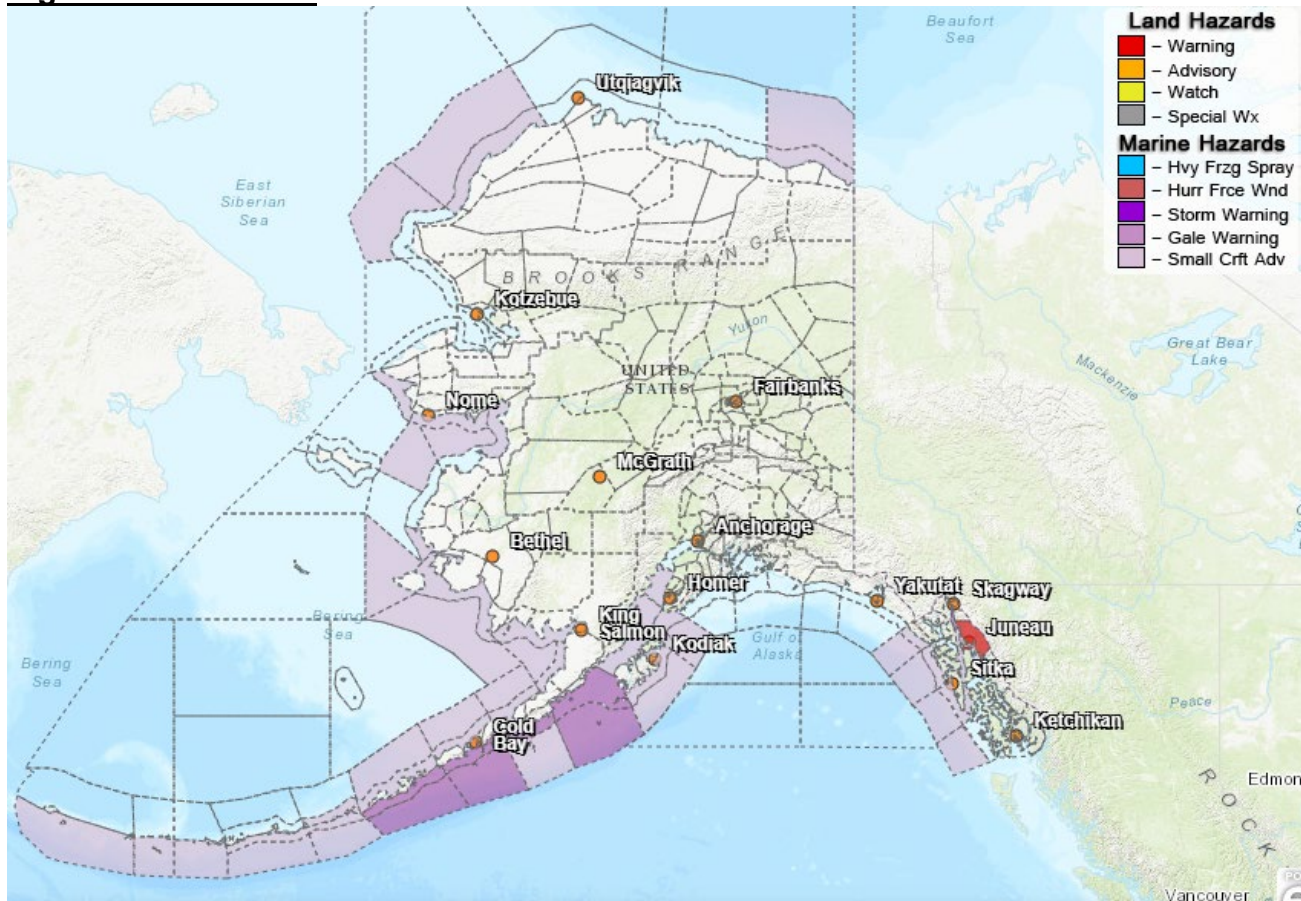

Significant Weather:

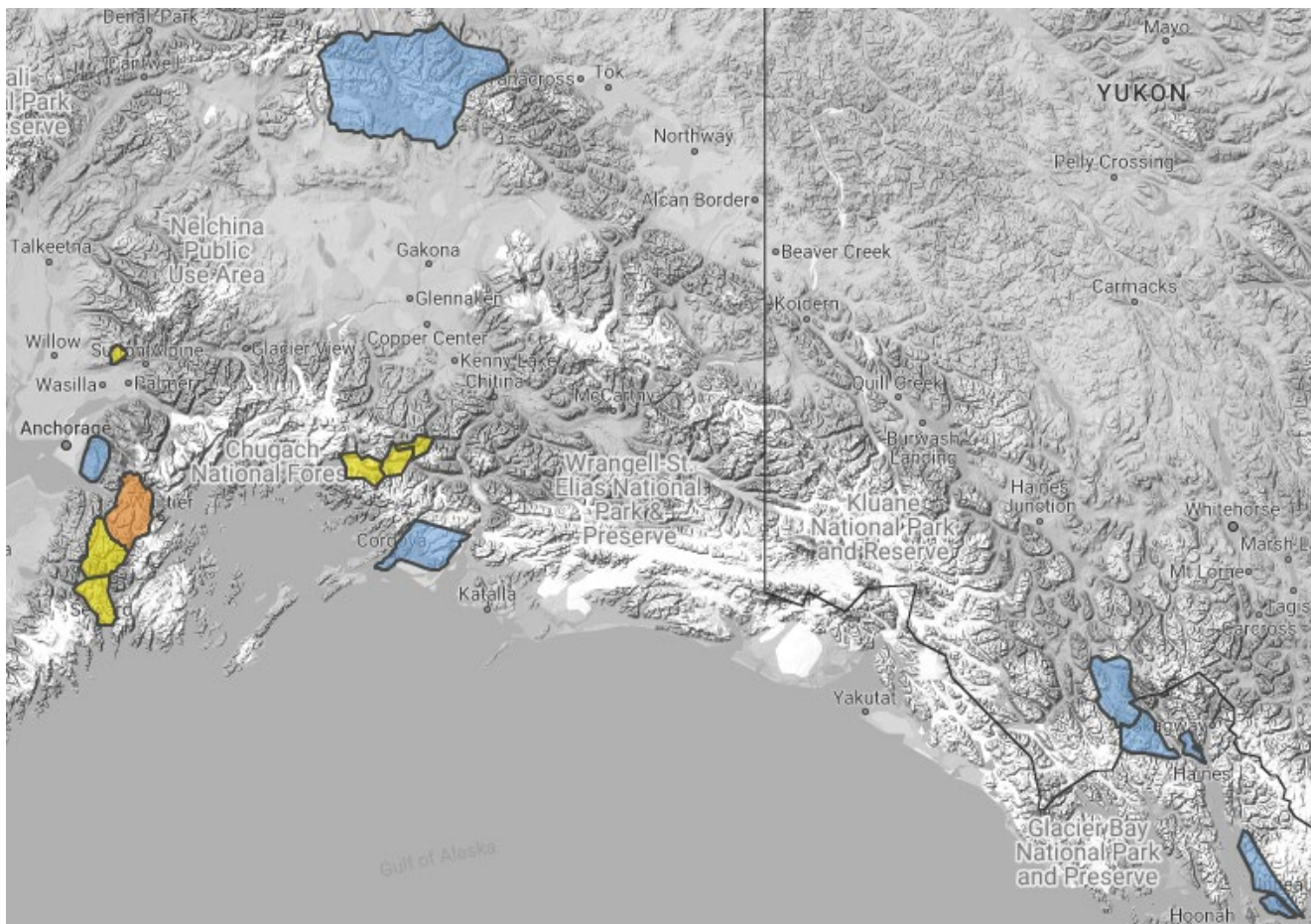
