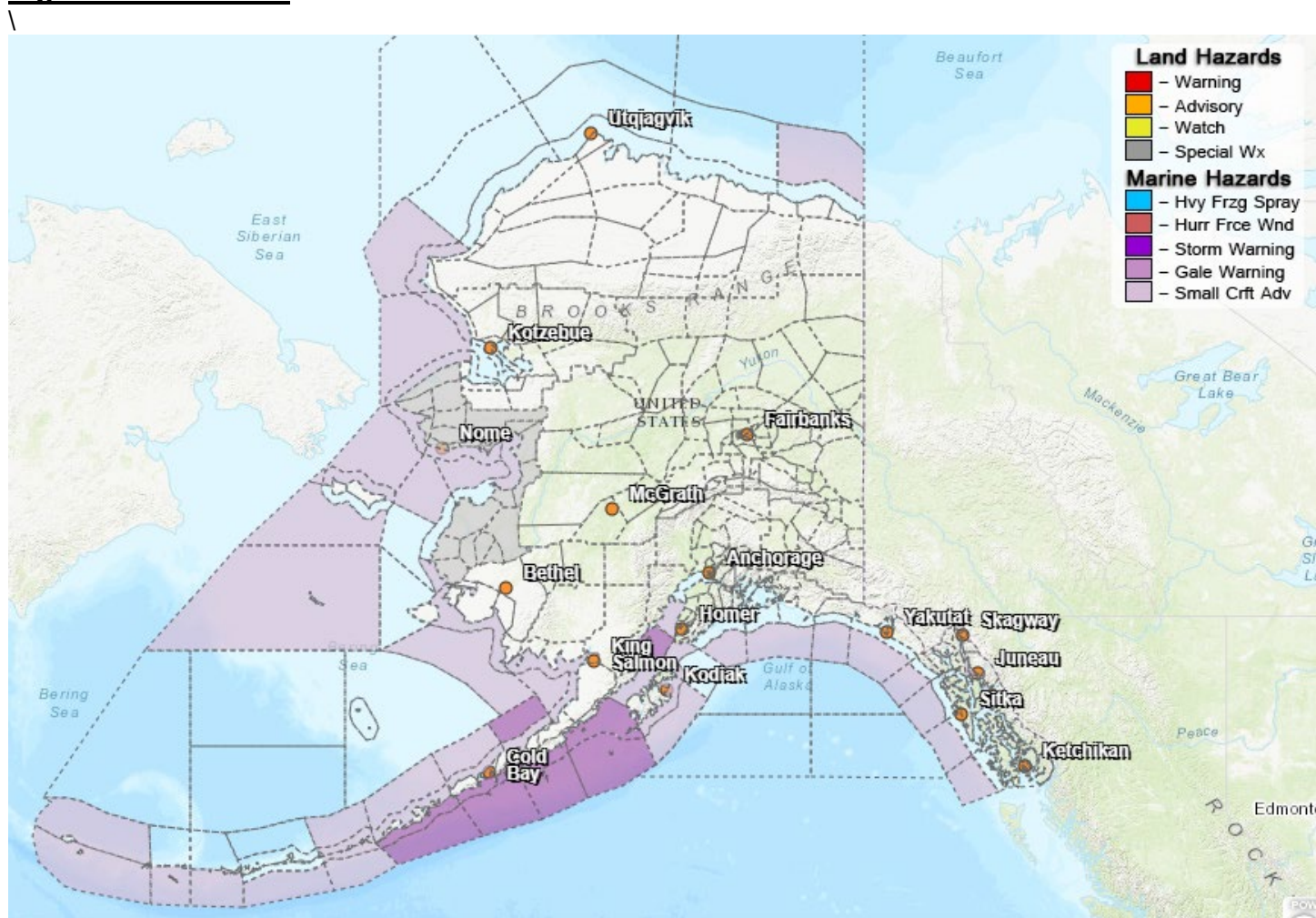

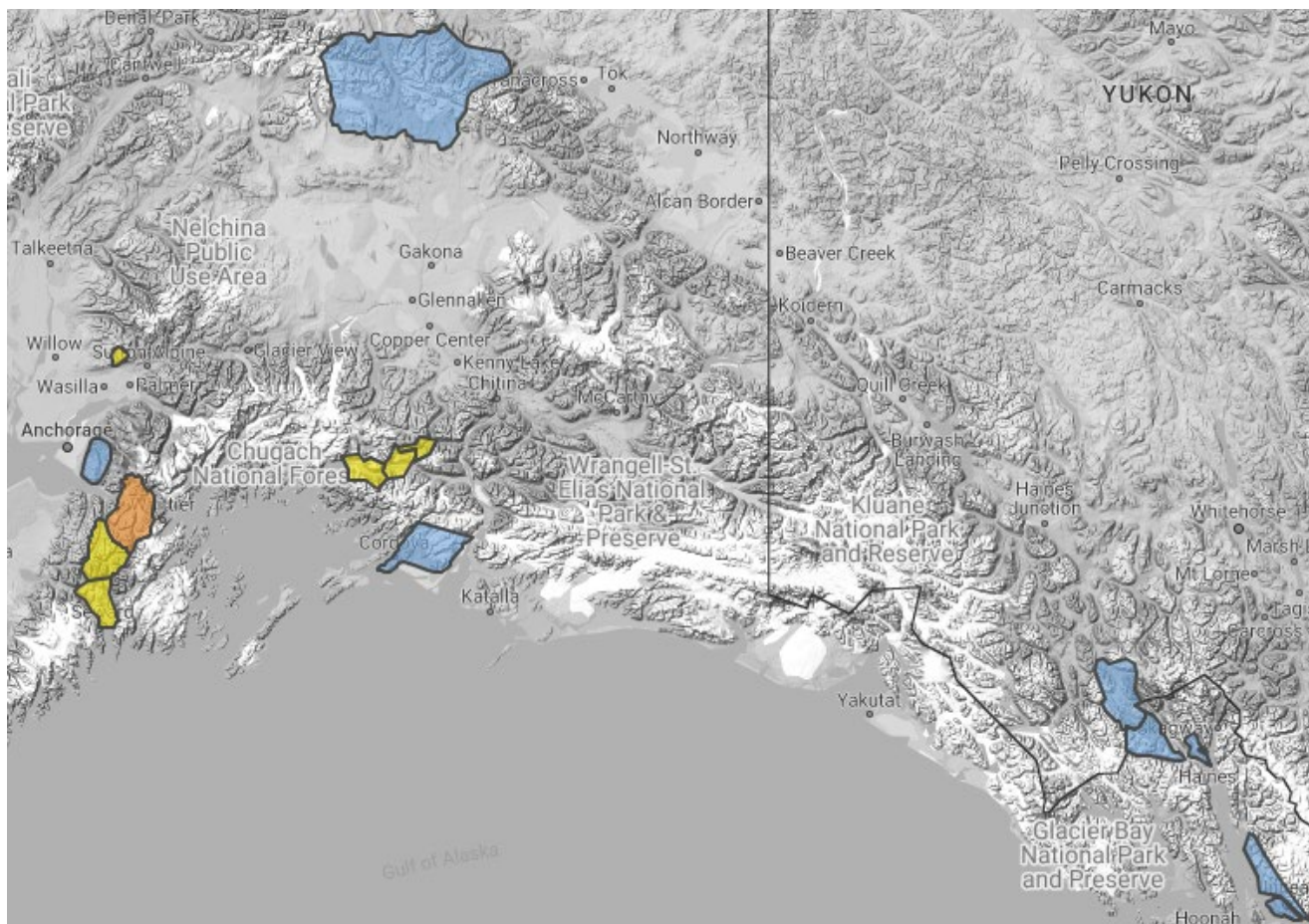
Special Weather Statement: Mixed Precipitation this weekend (glaze ice, freezing drizzle and snow)
