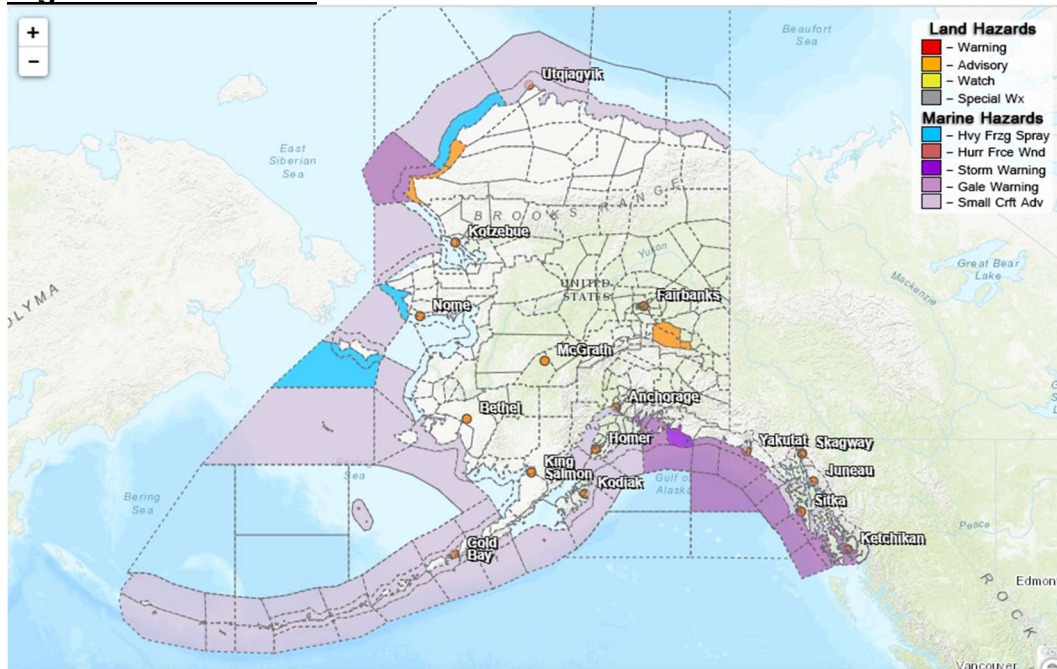

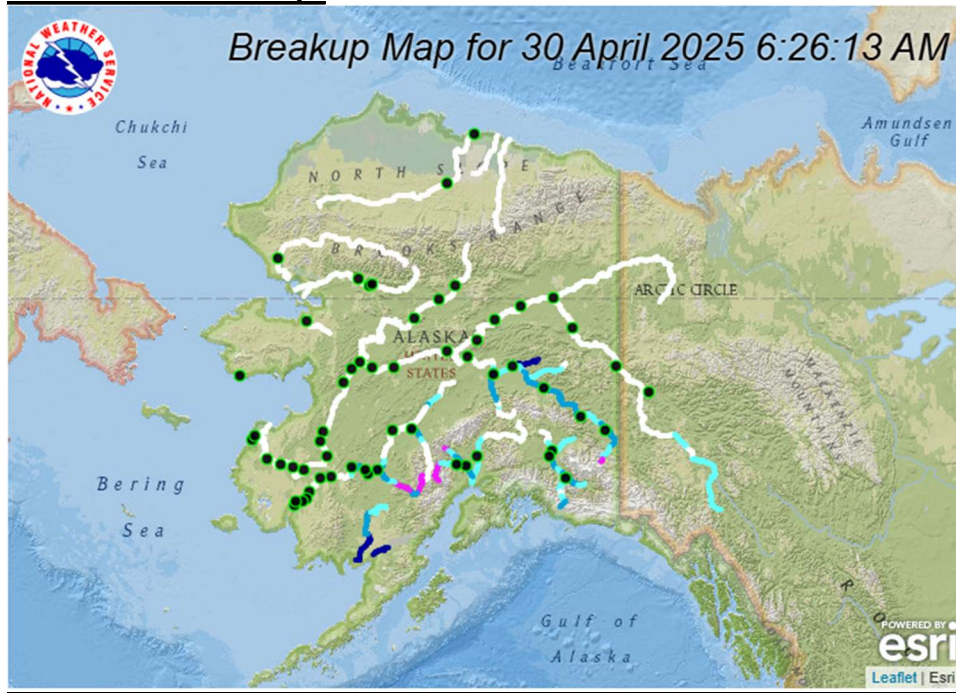

The Alaska Interagency Coordination Center is at Preparedness Level: 1

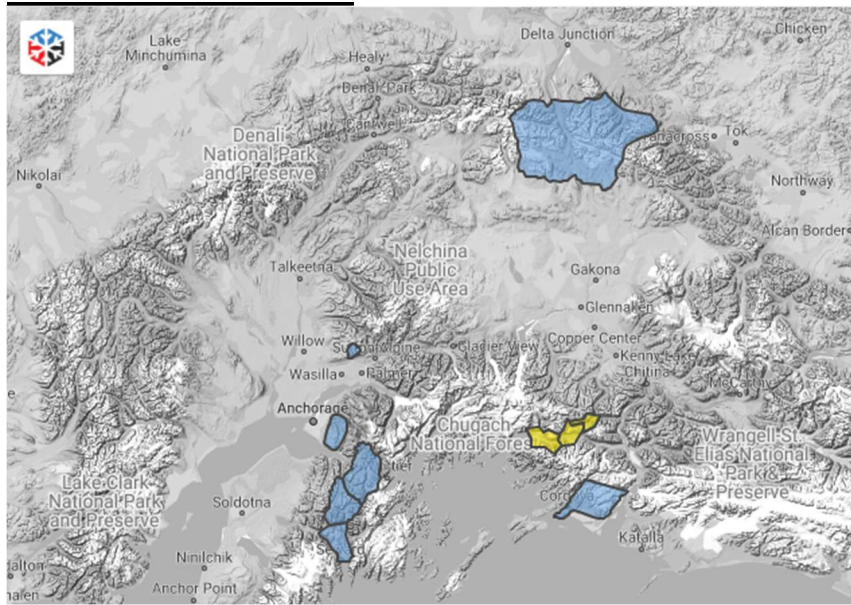
