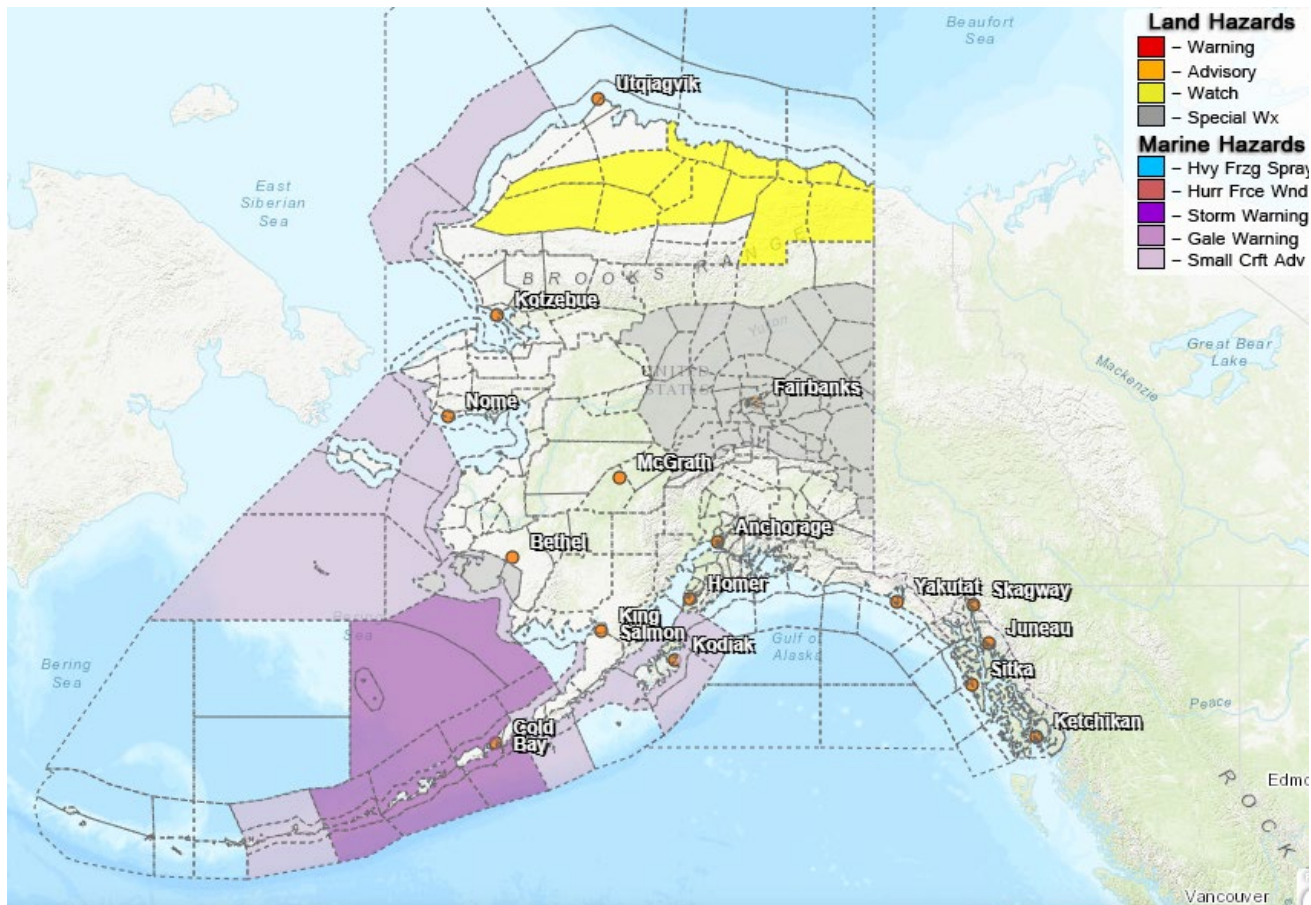

### **Special Weather Statement: Kuskokwim Delta Coast and Nunivak Island**

Prolonged Southerly Flow Into Coastal Kuskokwim Delta through Sat, including increased winds and water levels higher than normal highest tide line. Coastal erosion and flooding of low lying areas is possible.

Temps rapidly rising into the 80s through the week above season normals by late week.
