Significant Issues:

Red Flag Warning: Upper Koyukuk Valley; Dalton Highway Summits; Yukon Flats; White Mountains and High Terrain South of the Yukon River

The statewide fire risk continues to increase. State Forestry moved to Planning Level 2 (of 5) due to Red Flag Warnings, Heat Advisories and Fire Weather Watches across the Interior and SW regions through Tuesday night. SEOC is monitoring the conditions and stands ready to assist.

Road Washout Dalton Highway:

On Sunday, the Alaska Department of Transportation and Public Facilities (DOT/PF) advised SEOC about a flooding washout on the Dalton Highway around Milepost 315 that closed the Highway. DOT/PF had established incident command and was actively working on roadway repair and mitigation. No immediate state disaster assistance was requested. SEOC remains in regular contact with DOT/PF. 
