Significant Issues:

Wildland Fires:

Starting on Thursday's holiday and then through Friday and Saturday, multiple serious wildland fires ignited or rapidly increased with Red Flag conditions, lightning, and high pressure set up over most of the state.

Evacuations are in place on multiple fires (see below under Alaska Wildland 2025 Fire Season) with damage reports on all fires pending.

The Parks Hwy has closed intermittently due to fire activity and pilot car operations are underway in the area of Mile Post 272 (see under Travel Alerts and Conditions 511).

Forecasted weather has some relief by today with additional improvement by Thursday.

SEOC has deployed the following in support of Fire Response:

Fairbanks North Star Borough:

- SEOC DIVSUP embedded in the FNSB EOC supporting evacuation and sheltering

Denali Borough:

- MEOC (mobile Emergency Operations Center – Command Post) deployed at request of Borough.
- SEOC DIVSUP embedded in the Denali EOC supporting evacuation and sheltering.
- SEOC OSC in field today (Denali Borough)
- Mass Care Group actively working Mass Care support for evacuation, sheltering, and destroyed residences.

Alaska National Guard:

- One JBER Type 2 Tender and Red Carded Crew with command vehicle for fire suppression.
- 2 UH-60s Blackhawks with Bambi buckets for fire suppression
- National Guard Armory in Fairbanks opened as mobilization center

Old Glenn Hwy Flooding – Butte:

SEOC received a report yesterday of flooding on the Old Glenn Highway in the Butte area. The flooding was threatening MEA power poles with about 400 customers with potential to lost power. SEOC coordinated

response with Mat-Su Borough, DOT/PF and MEA. SEOC DIVSUP assigned.

Crooked Creek Structural Fires:

SEOC received a report yesterday of 2 residential structures destroyed from a structural fire that was ignited by lightning. 8 persons sheltering with relatives/neighbors within community. SEOC Mass Care Group coordinating support and Red Cross engaged.

National Terrorism Advisory System (NTAS) Bulletin:

Federal DHS issued a NTAS Bulletin in response to American engagement with Iran.

Concerns are for cyber-attack, Homegrown Violent Extremists, terrorism. No specific threats to America or Alaska. See attached.

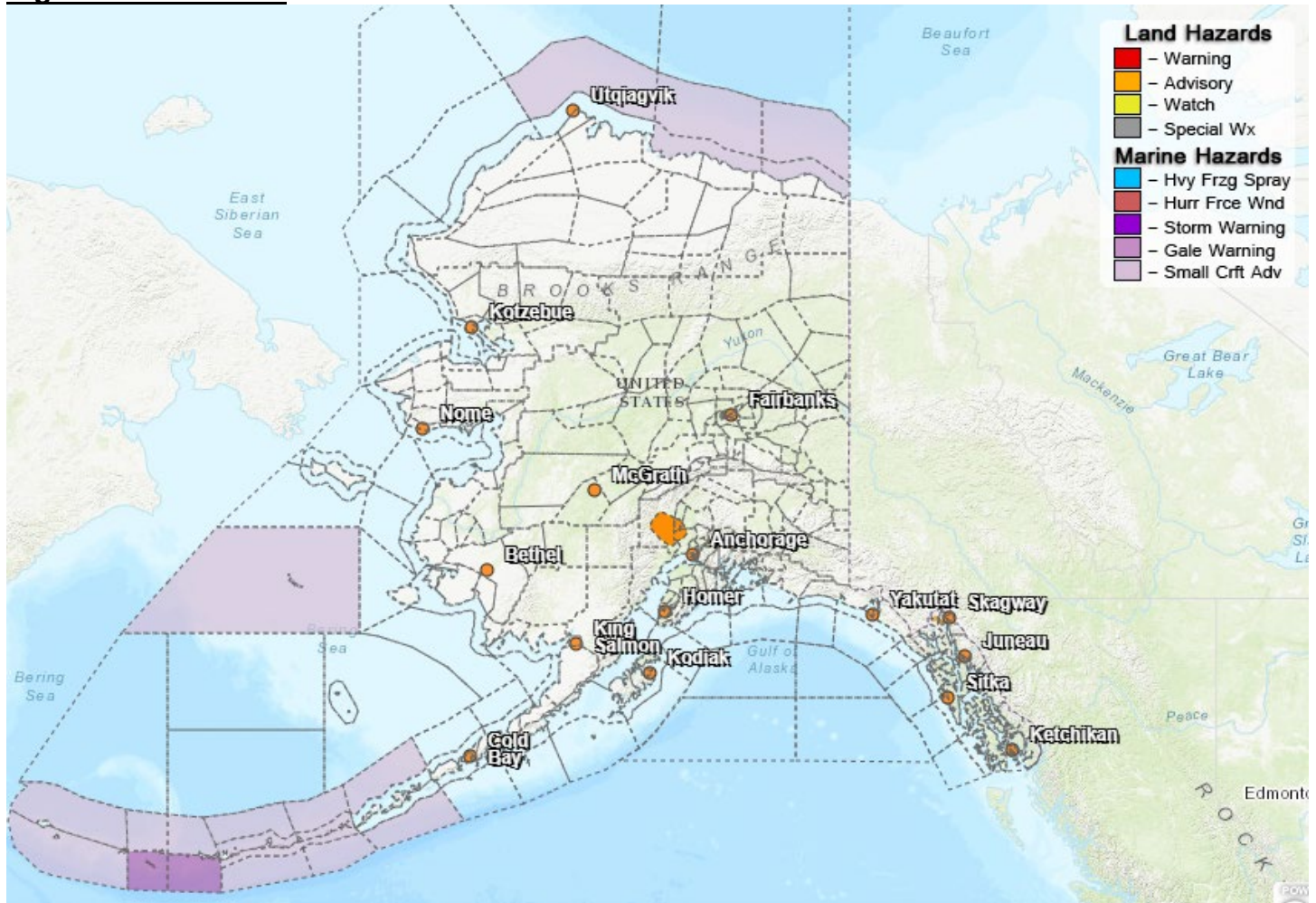

Flood Advisory: Western Susitna Valley; Southern Susitna Valley; Central Susitna Valley

- Possible flooding from snowmelt in effect until 10 PM AKDT Tuesday. In particular the Yentna and Swentna rivers and nearby tributaries may be impacted

Flood Advisory: Haines Borough and Klukwan

- Flood Adviosry for Snowmelt remains in effect until 10 PM AKDT Tuesday, in particular the Chilkat River near areas around MP 14 & 24 of the Haines Highway, near Klukawan and the Chilkat River Bridge

Flood Advisory: Lower Matanuska Valley

- Flood Advisory: in effect until noon AKDT Wednesday. Flooding caused by snowmelt and channel shift of the Matanuska River near Butte, AK.
