Significant Issues:

Wildland Fires:

Fire activity across the state continues to increase, however overnight weather favored efforts to protect lives and property. Cooler temperatures, some precipitation, and lower barometric pressures are forecasted through Friday that will continue to aid with suppression efforts. Efforts also continue to obtain damage assessments. For specific fire management details, please refer to the AICC dashboard (linked at the bottom of this document)

Evacuations are in place on multiple fires (see below under Alaska Wildland 2025 Fire Season) with damage reports on all fires pending. Of note, Denali Borough and Fairbanks North Star Borough updated evacuation zones yesterday, with no notable changes overnight.

For travel concerns please reference Alaska 511. Fire impacts can be found on the map with the Weather Incidents layer checked. The Parks highway will continue with DOT piloting traffic as conditions allow through Bear Creek Incident.

SEOC has deployed the following in support of Fire Response:

Fairbanks North Star Borough:

- SEOC DIVSUP embedded in the FNSB EOC supporting evacuation, sheltering and coordination of resources
- Mass Care Group actively working Mass Care support for evacuation, sheltering, and destroyed residences.

Denali Borough:

- MEOC (mobile Emergency Operations Center – Command Post) deployed at request of Borough, will be utilized at Fire Command Post by AK CIMT.
- SEOC DIVSUP embedded in the Denali EOC supporting evacuation and sheltering.
- SEOC OSC in field today (Denali Borough)

Tok/Seven Mile Lookout Fire

- SEOC OSC confirmed with AK Division of Forestry that there are no sheltering needs for evacuated residents or additional resources needed from DHSEM on Monday evening.

Alaska National Guard:

- Added an additional 3 firefighters for a total of 8 deployed on JBER Type 2 Firefighting Tender.
- 2 UH-60s working as needed on fire assignments
- Mobilization Center for firefighters coming in from lower-48 at Fairbanks Guard Armory.

Old Glenn Hwy Flooding – Butte:

SEOC personnel responded to Matanuska River flooding adjacent to the Old Glenn Highway mi 13-15 to assess damages and assist home and business owners. Mitigation happening by MEA and DOT&PF with reports of water levels dropping as observed by responders and residents. SEOC will continue to gather information and monitor impacts and mitigation efforts.

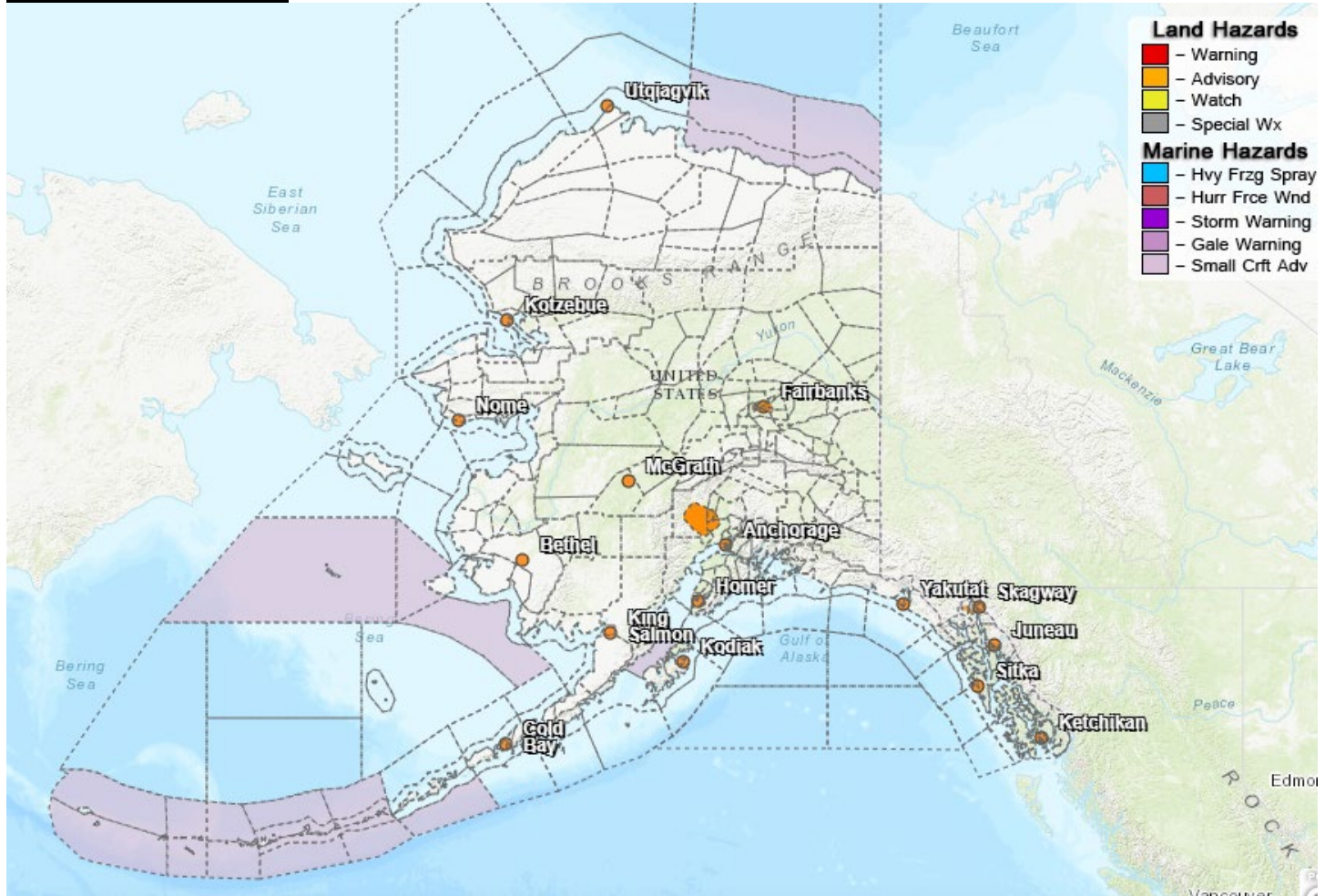

Flood Advisory: *Western Susitna Valley; Southern Susitna Valley; Central Susitna Valley*

- Possible flooding from snowmelt in effect until 10 PM AKDT Tuesday. In particular the Yentna and Swentna rivers and nearby tributaries may be impacted

Flood Advisory: *Haines Borough and Klukwan*

- Flood Advisory for Snowmelt remains in effect extended to 10 PM AKDT Wednesday, in particular the Chilkat River near areas around MP 14 & 24 of the Haines Highway, near Klukawan and the Chilkat River Bridge

Flood Advisory: *Lower Matanuska Valley*

- Flood Advisory: in effect until noon AKDT Wednesday. Flooding caused by snowmelt and channel shift of the Matanuska River near Butte, AK.
