Significant Issues:

Wildland Fires:

Weather continues to favor suppression efforts throughout the week. SEOC continues to collect damage assessments and assist local jurisdictions with Mass Care/Sheltering needs. For specific fire management details, please refer to AICC Dashboard (link at the bottom of this document).

Tok/Seven Mile Lookout Fire

Areas previously in GO evacuation have been downgraded to SET as firefighters began to make progress. Residents can now return home but please be cautious of emergency personnel in the area.

FNSB Sheltering

Fairbanks North Star Borough and the Red Cross have opened a shelter at Hutchinson High School, 3750 Geist Road, Fairbanks, AK 99709. It is open 24 hours a day for evacuating residents to walk in. Any animals needing emergency sheltering can be brought to the FNSB Emergency Pet Shelter at 3175 Peger Road, Fairbanks.

Nat guard assets deployed to assist with fire suppression ops throughout the state, including Nelchina Glacier Fire, East Gakona River Fire, Bear Creek Group, and FNSB.

Old Glenn Hwy Flooding – Butte:

SEOC continues to collect damage assessments and communicate with mitigation resources. Water levels are expected to very slowly recede over the next few days as temperatures remain cooler than last week which has lessened the rate of snow melt in the mountains upriver.


