**Significant Issues:**

**Red Flag Warning:**

There is a RED FLAG WARNING in effect for eastern and eastern interior portions of the State from 10am to 10pm Wednesday. A red flag warning means conditions are occurring or will occur which could lead to the development of large and dangerous fires. SEOC is monitoring the weather conditions for increasing fire activity throughout the rest of the week and weekend.

**Denali Borough Fire Declaration:**

SEOC is implementing Governor Dunleavy's declaration of the state disaster emergency for the Denali Borough. SEOC has received 1 Individual Assistance (IA) application, with IA hotline and website open for registration.

**Mat-Su Borough Flooding Declaration:**

SEOC is implementing the state Public Assistance disaster for the flooding on the Old Glenn Hwy.

**Alert:** Parks Highway MP 264.5 to MP 276: Please expect pilot cars and delays due to fire activity.

**Alert:** Closure on ramp from Homer Dr. to New Seward Highway. All lanes closed.

**Incident:** Parks Highway MP 328: Be alert to wildland equipment and crews entering/exiting highway MP 328. Please reduce speed and drive with caution. Flaggers may be in the area to assist with traffic flow.

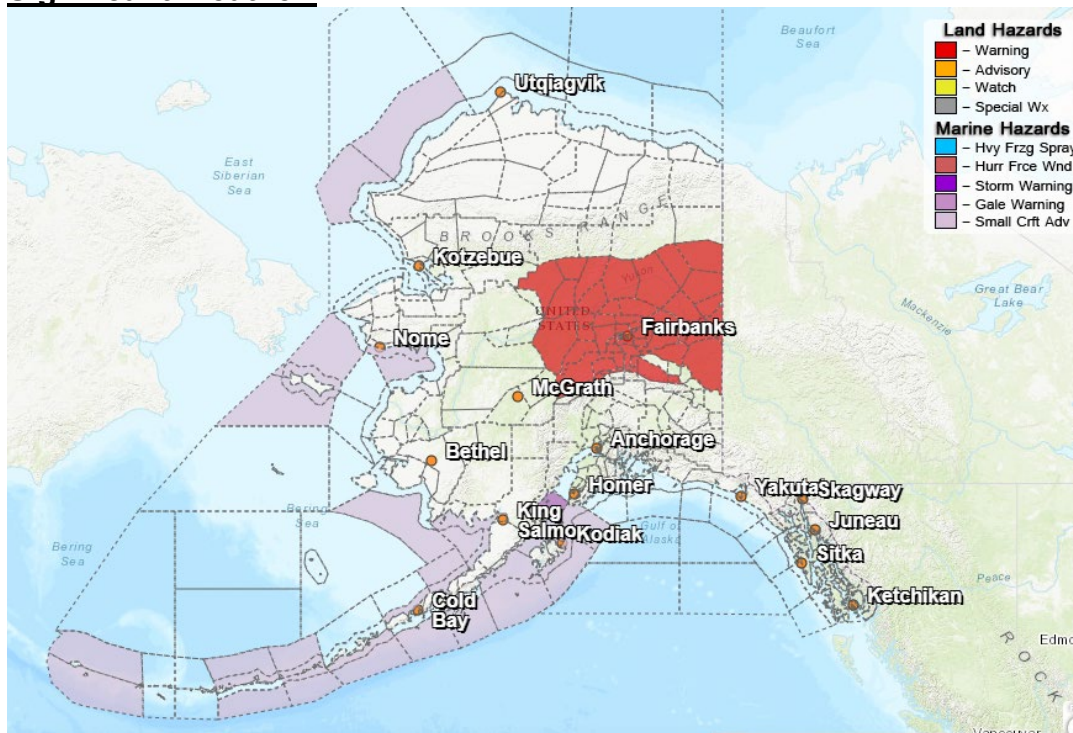

**Red Flag Warning:**

Red flag warning in effect from 10am to 10pm Wednesday for Interior and Eastern Interior portions of Alaska. Winds will be 10 – 20 mph with gusts up to 30mph and the temperature will be in the upper 80s. Hot, dry, windy conditions may lead to rapid spread of fires.
