Significant Issues:

Wildfire:

SEOC DivSup embedded in Denali Borough and Fairbanks North Star Borough has demobilized to support Mass Care, Fire suppression efforts, and local municipalities remotely. The SEOC remains active with regard to facilitating meetings, press releases and notifications to residents.

SEOC COOP Drill:

SEOC is holding a full-scale Continuity of Operations Drill today at the Alcantra DHS&EM Warehouse. SEOC recalled all DHS&EM staff and SEOC Agency Representatives/Liaisons and will run full SEOC operations remotely, simulating JBER SEOC is unavailable.

Travel Alerts and Conditions:

Parks Highway MP 264.5-276 (Bear Creek Fire): Pilot car and flagger operations have ended. Speeds are temporarily reduced to 45 mph in this section. Please use caution and remain alert for fire crews working nearby.

Parks Highway MP 341-308 (Nenana Ridge Complex): Pilot Car operations are in place with wait times currently estimated at 1 hr, depending on road conditions and ongoing fire crew operations along the way.

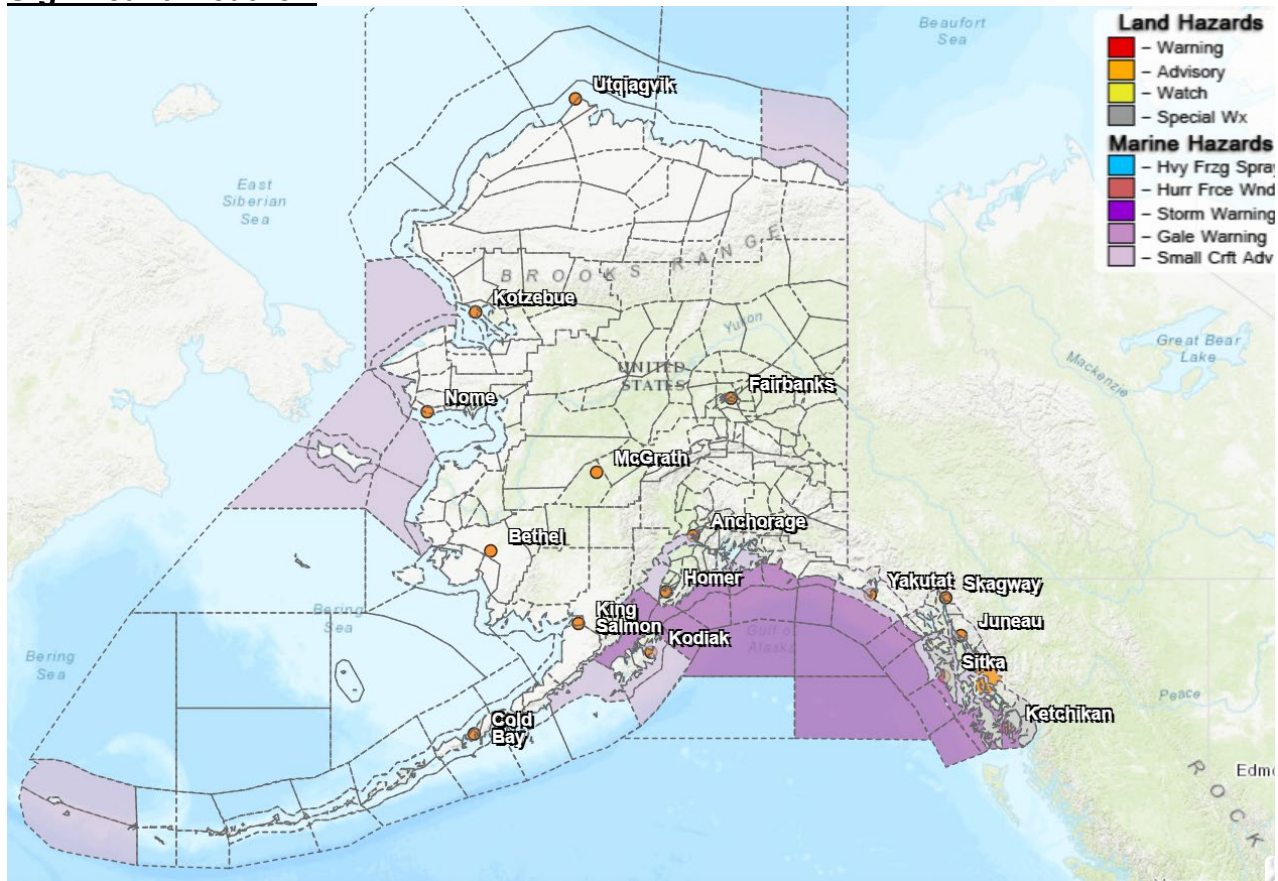

Flood Advisory:

Ketchikan Gateway Borough – Flood Advisory Until 1145am Friday. Ward Lake and nearby areas. Heaviest rainfall will be this evening into early Friday morning.

Special Weather Statement:

City and Borough of Sitka; Prince of Wales Island; Ketchikan Gateway Borough; Annette Island – Heavy rain potential for southern panhandle Thursday into Friday. Areas may receive 2-3 inches of rain in 24 hr period.
