Significant Issues:

Juneau Glacial Lake Outburst Flood

Suicide Basin released yesterday on the Mendenhall River with a flood crest above the previous flood of record in 2024. As the flood waters rapidly receded, the flood warning was canceled in the afternoon, evacuation for residents lifted, Temporary Flight Restrictions lifted, and shelters demobilized. No injuries were reported. Initial reports indicate that the installed flood barriers worked effectively. CBJ/Tlingit-Haida Unified Command will continue to assess them with the US Army Corps of Engineers today.

Flood damage assessments will begin today. Preliminary reports indicate damage to the Back Loop Bridge and an internet fiber optic cable as well as some homes flooded in low lying areas. To support damage assessments and recovery, the Juneau School District has suspended classroom instruction for today.

SEOC remains activated to support the flood recovery in Juneau and continues to have a Branch Director and Division Supervisor in Juneau supporting the City and Borough Juneau (CBJ)/Tlingit-Haida Unified Command.

Under the Governor's declaration of disaster emergency, SEOC has begun implementation of the State Individual Assistance program for any Juneau residents that suffered flood impacts as well as the State Public Assistance disaster recovery program.

President Summit

SEOC will be activated tomorrow in Unified Command with the Alaska Department of Public Safety to provide any support needs related to Friday's Presidential Summit. This activation will be concurrent with continued full support for the response and recovery in Juneau described above.

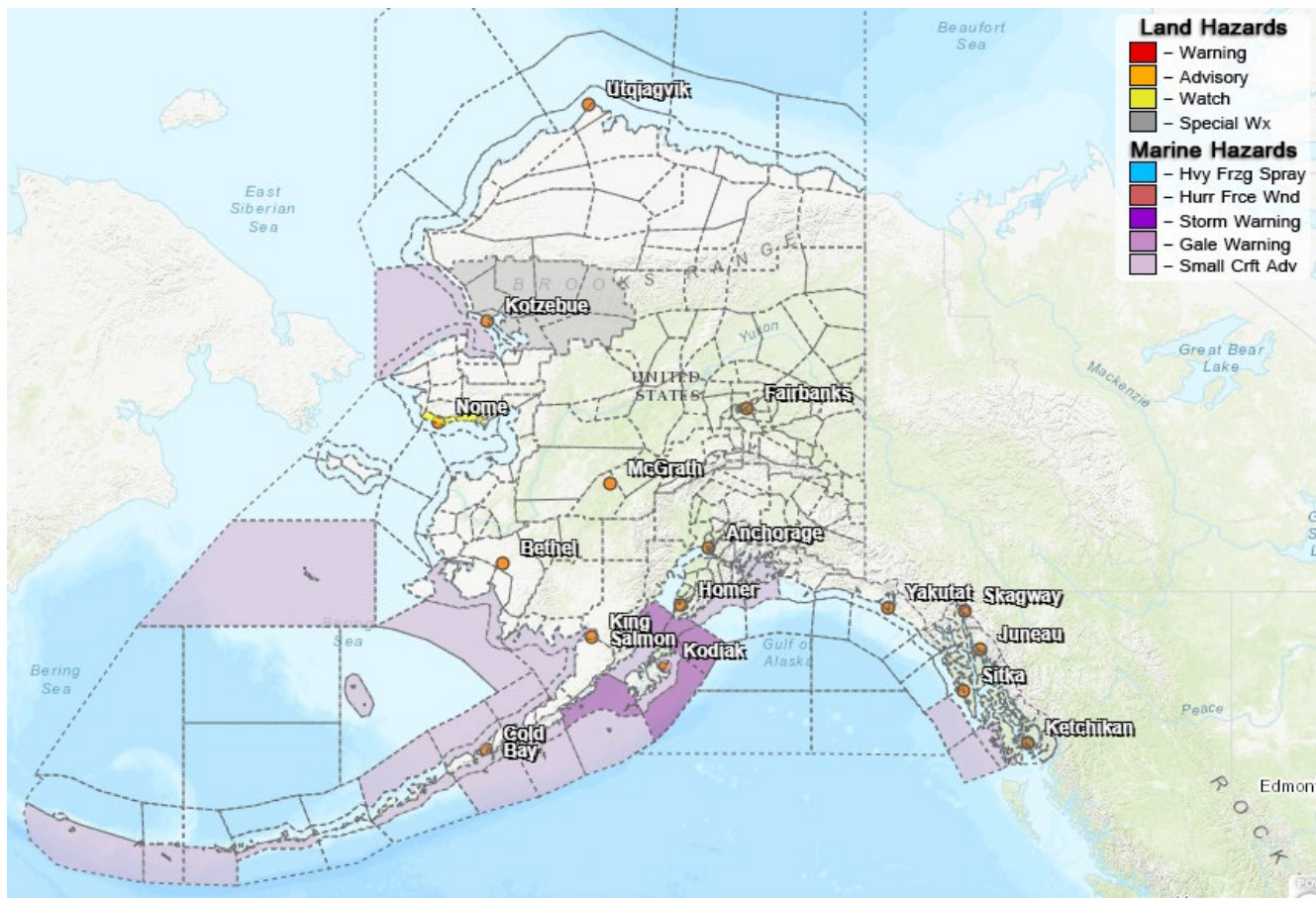

Significant Weather:



Flood Watch – Southern Seward Peninsula Coast including Nome, White Mountain, and Golovin: in effect through Thursday evening. Flooding in main stem rivers near the coast caused by excessive rainfall will be likely approx. 1 day after rainfall stops.

Hydrologic Outlook – South Slopes of the Western Brooks Range; Noatak Valley; Kivalina and Red Dog Dock; Lower Kobuk Valley; Upper Kobuk Valley: Prolonged Heavy Rain continues through Wednesday in the Western Brooks Range, total rainfall of 1.5-4 inches from a prolonged heavy rain event. Rain is expected to end early Thursday morning.
