Significant Issues:

Juneau Glacier Lake Outburst Flood

SEOC is transitioning to recovery mode as both deployed personnel demobilize from Juneau. This transition also marks the change in Preparedness Level from Level 2 to 1. DHSEM staff continue to support Juneau per the Governor's declaration of disaster for individual and public assistance.

Tracy Arm Landslide

USGS has published an overview regarding a landslide that occurred on Sunday August 10th at 0526 AKDT above the toe of the South Sawyer Glacier in the Tracy Arm, south of Juneau which generated a tsunami.
