Significant Issues:

Denali Borough Fires - SBA Economic Injury Disaster Declaration

SEOC received word of an SBA Economic Injury Disaster Declaration dated today that opens the availability of low interest loans to businesses impacted by the fires this summer in and around the Denali Borough including Nenana, Healy, and the upper portions of the Parks Hwy where highway disruptions lead to summer tourist income losses.

Included “contiguous counties” are Denali Borough, Yukon-Koyukuk REAA, Bering Strait REAA, Delta/Greely REAA, Fairbanks North Star Borough, Iditarod Area REAA, Matanuska-Susitna Borough, North Slope Borough, Northwest Arctic Borough, Yukon Flats REAA.

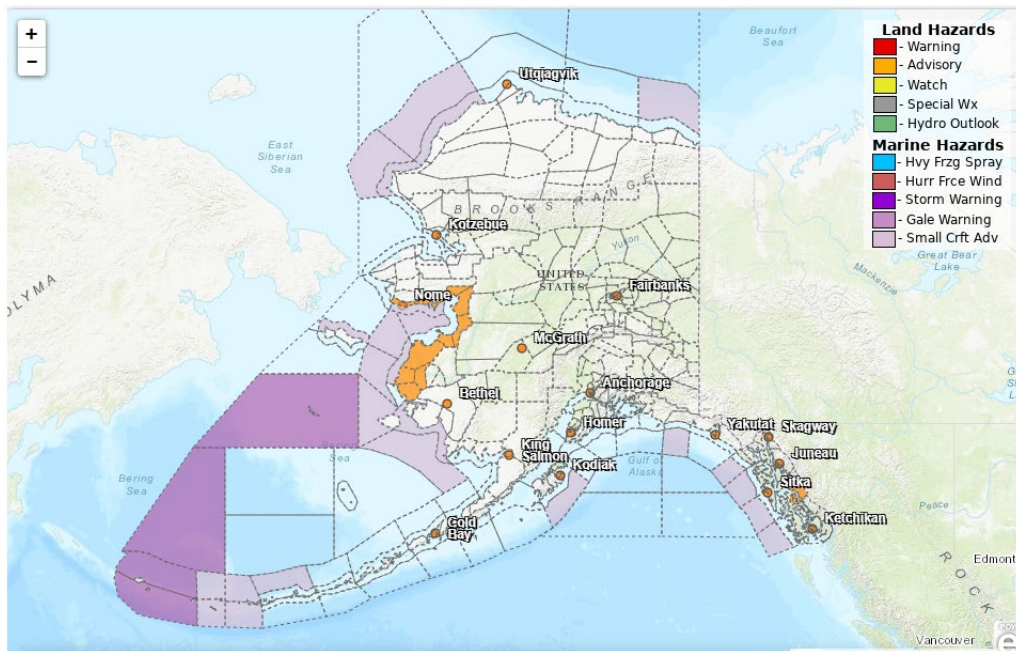
