Significant Issues:

Governor Dunleavy has declared a disaster for the Yukon-Koyukuk REAA in response to widespread community flooding in Allakaket. The SEOC deployed a Division Supervisor to Fairbanks over the holiday weekend to assist Tanana Chiefs Conference and coordinate emergency response. The Dept of Environmental Conservation, Red Cross, Division of Forestry, Dept of Transportation and Public Facilities, Alaska Native Tribal Health Consortium, Dept of Health, Salvation Army and other Volunteer Organizations Active in Disasters (VOAD) have all been engaged to provide resources and respond to the needs of Allakaket and impacted communities in the Koyukuk River Valley.

Multiple areas of the state are seeing higher than normal river levels from a series of heavy rainstorms last week and over the holiday weekend. Some areas of the state will see another weaker system continue to drop rainfall throughout the upcoming week. See the Significant Weather section below for ongoing Watch/Advisory/Warnings from the National Weather Service. The SEOC is engaged with emergency managers in the Northwest Arctic Borough, Matanuska-Susitna Borough, Kenai Peninsula Borough and Cordova to monitor and assist with any response and recovery needs.

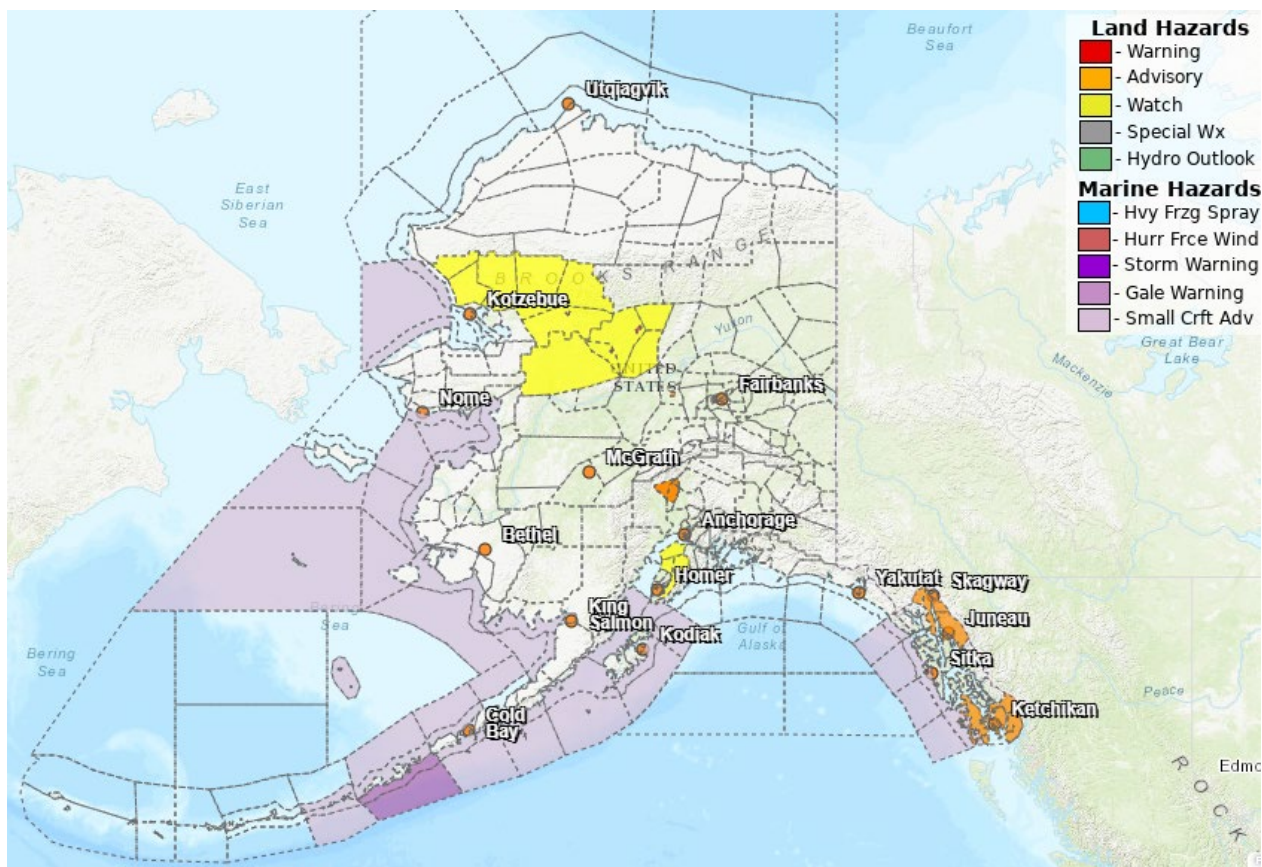

Significant Weather:



Flood Warning – Upper Koyukuk Valley: Flooding caused by excessive rainfall. Water levels at Allakaket should continue to drop. Warning in effect until noon Tuesday.

Flood Warning – **Lower Koyukuk Valley:** Flooding caused by excessive rainfall. The gauge at Hughes reported a stage of 64.22 ft with water receding very slowly. Warning in effect until 4PM Tuesday.

Flood Advisory – **Upper Kobuk Valleys:** Kobuk River at Kobuk, minor flooding in low-lying areas, with another wave of rain expected. River levels may rise again Tuesday afternoon into Wednesday. Advisory in effect until noon Wednesday.

Flood Watch - **South Slopes of the Western Brooks Range; Noatak Valley; Upper Kobuk Valleys; Lower Koyukuk Valley; Upper Koyukuk Valley:** Including the Noatak, Kobuk and Koyukuk River. Excessive runoff from last week's rainfall is resulting in flooding of rivers, creeks, streams, and other low-lying and flood-prone locations. Another rainmaker will arrive on Wednesday evening. Watch in effect through Wednesday morning

Flood Advisory – **Central Interior:** Tanana River near Manley Hot Springs has crested at 13.61 ft and levels have remained steady since about 5 AM Monday morning. Advisory in effect until 1015 AM Tuesday.

Flood Advisory - **Western Susitna Valley; Central Susitna Valley; Northern Susitna Valley:** Northern Susitna Valley in the Petersville area. Ongoing flooding along the headwaters of Peters and Cache Creeks will be exacerbated by additional rainfall continuing with another round of rain set to occur on Wednesday. Advisory in effect until 915 AM Thursday.

Flood Watch - **NW Kenai Peninsula; Skilak Lake:** Skilak Lake and the Middle Kenai River near Skilak Lake and the Kenai River Downstream of Skilak Lake. Currently expecting the Kenai River to rise steadily at Skilak Lake outlet, cresting to moderate flood stage Friday or Saturday. Watch in effect through Sunday morning.

Heat Advisory - **Haines Borough and Klukwan; City and Borough of Juneau; Prince of Wales Island; Ketchikan Gateway Borough; Annette Island:** Temperatures up to 80 expected, in effect from noon Tuesday to 7 PM Wednesday.
