**Significant Issues:**

The Division Supervisor for Allakaket and Koyukuk River flooding has returned from a deployment to Fairbanks. The SEOC will continue to support the Tanana Chiefs Conference as the impacted communities transition from response to recovery.

The community of Deering and Northwest Arctic Borough have issued a disaster declaration for issues of erosion related to heavy winds and high water. The SEOC is engaged with community leaders to establish a scope of support.

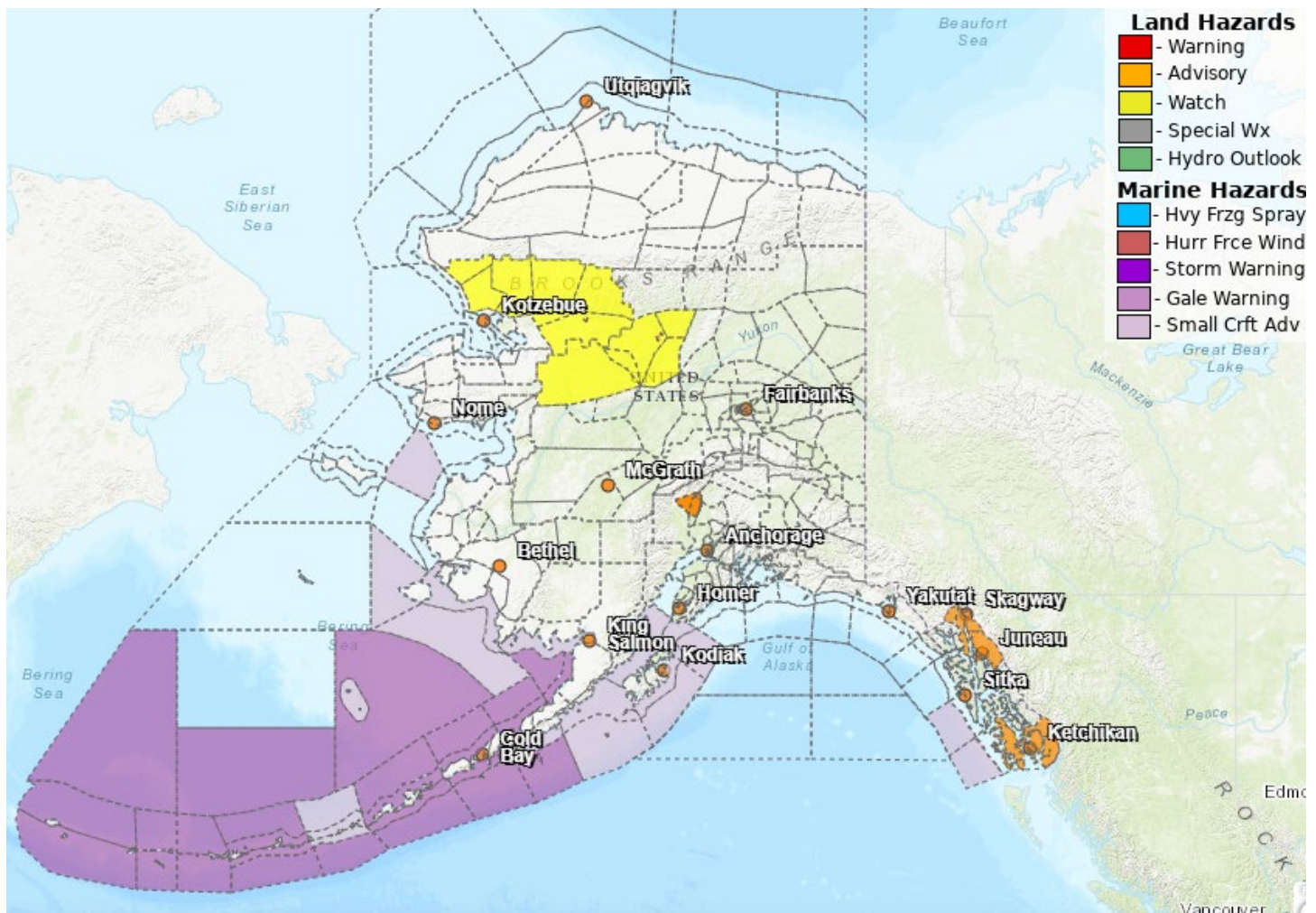

### **Significant Weather:**



Flood Advisory – **Upper Koyukuk Valley:** Flooding caused by excessive rainfall. Water levels at Allakaket should continue to drop. Warning in effect until 4 PM Wednesday.

Flood Advisory – **Upper Kobuk Valleys**: Kobuk River at Kobuk, minor flooding in low-lying areas, with another wave of rain expected. River levels may rise again Tuesday afternoon into Wednesday. Advisory in effect until noon Wednesday.

Flood Watch - **South Slopes of the Western Brooks Range; Noatak Valley; Upper Kobuk Valleys; Lower Koyukuk Valley; Upper Koyukuk Valley**: Including the Noatak, Kobuk and Koyukuk River. Excessive runoff from last week's rainfall is resulting in flooding of rivers, creeks, streams, and other low-lying and flood-prone locations. Another rainmaker will arrive on Wednesday evening. Watch in effect through Thursday afternoon

Flood Advisory - **Western Susitna Valley; Central Susitna Valley; Northern Susitna Valley**: Northern Susitna Valley in the Petersville area. Ongoing flooding along the headwaters of Peters and Cache Creeks will be exacerbated by additional rainfall continuing with another round of rain set to occur on Wednesday. Advisory in effect until 915 AM Thursday.

Heat Advisory - **Haines Borough and Klukwan; City and Borough of Juneau; Prince of Wales Island; Ketchikan Gateway Borough; Annette Island**: Temperatures up to 80 expected, in effect from noon Tuesday to 7 PM this evening.
