Significant Issues:

Flooding along the Southern Brooks Range – Several communities were impacted by floodwaters from heavy rains that fell late last week and through the holiday weekend. As the SEOC assisted with response, a number of our partners remain engaged in recovery. Tanana Chiefs Conference has partnered with personnel from Alaska Dept of Environmental Conservation to ensure spill containment and safe drinking water and Alaska Division of Forestry has provided valuable manpower for shoring up at risk areas. Red Cross, Salvation Army and the Food Bank of Alaska continue to have prolific impacts for the residents of Allakaket and Kobuk as food, water and shelter were needed by evacuated and displaced residents. DHSEM Disaster Response personnel also remain engaged to move forward with recovery.

As the next wave of rain moves through the area, river levels are still expected to slowly recede and not reach crest levels from last week's storms. See significant weather section below for more information and current Advisory/Watches.

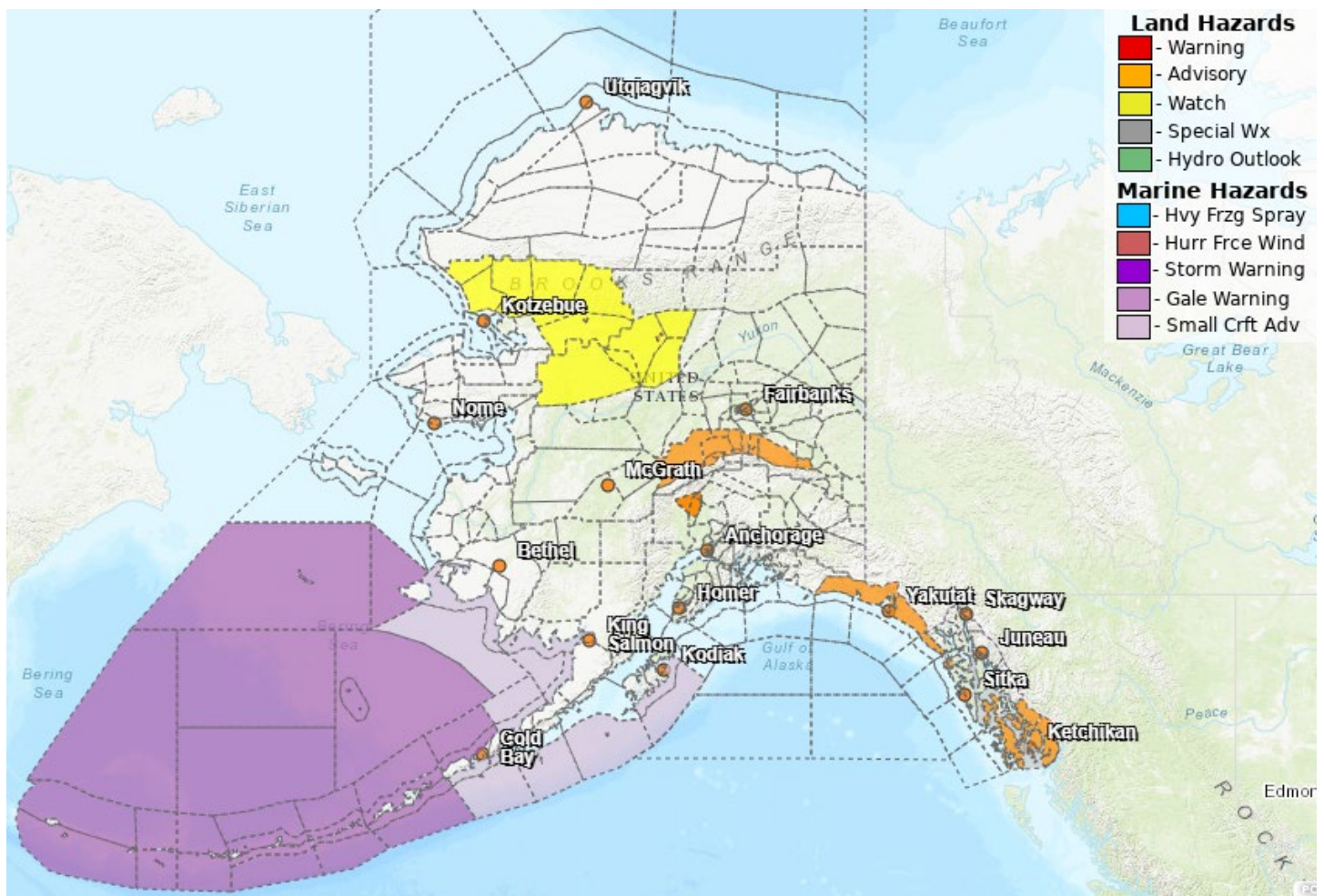

Significant Weather:



Flood Advisory – **Upper Koyukuk Valley:** Flooding caused by excessive rainfall. The Koyukuk River at Allakaket continues to slowly recede. Additional rain is expected through Thursday with 0.5-1.0 inch expected. Advisory in effect until 4 PM Thursday.

Flood Advisory – **Upper Kobuk Valleys:** Kobuk River at Kobuk, minor flooding in low-lying areas reported as of Wednesday morning. Another wave of rain is expected with 0.5-1.0 inch forecast through Thursday night. Advisory remains in effect until 4 pm Thursday.

Flood Watch - **South Slopes of the Western Brooks Range; Noatak Valley; Upper Kobuk Valleys; Lower Koyukuk Valley; Upper Koyukuk Valley:** Including the Noatak, Kobuk and Koyukuk River. Excessive runoff from last week's rainfall is resulting in flooding of rivers, creeks, streams, and other low-lying and flood-prone locations. Another rainmaker will arrive on Wednesday evening. Watch in effect until 4 PM Thursday.

Flood Advisory - **Western Susitna Valley; Central Susitna Valley; Northern Susitna Valley:** Northern Susitna Valley in the Petersville area. Ongoing flooding along the headwaters of Peters and Cache Creeks will be exacerbated by additional rainfall continuing with another round of rain set to occur on Wednesday. Advisory in effect until 10 am Friday.

Wind Advisory – **Northern Denali Borough; Eastern Alaska Range North of Trims Camp:** South winds 25-35 mph with gusts up to 55 mph. In effect until 10 am this morning.
