# Mag 7.8 Russian Coast Earthquake and Tsunami Advisory

A magnitude 7.8 earthquake on the Russian Kamchatka Coast triggered a Tsunami Advisory yesterday. The SEOC executed the Tsunami Advisory checklist and contacted all communities within the Advisory area. A small 30 cm wave was observed, and the Advisory was canceled at 1308 hours with no impacts reported.

#### Southeast Weather - Heavy Rain and Wind

A small landslide occurred in Juneau Tuesday evening. No injuries or significant property damage were reported, and the City and Borough of Juneau managed the response and assisted displaced residents locally.

Another atmospheric river has set up over Southeast Alaska. Up to 7 inches of rain are forecast, with landslides possible in Ketchikan and Metlakatla. This is expected to be a long-duration event with rain persisting through most of the weekend on already saturated soil. The SEOC is maintaining regular contact with Southeast communities and will remain on watch throughout the weekend to provide support as needed.

# 2025 Late August Storm Disaster Amendment \*view attachment

In response to a disaster declaration from the Matanuska-Susitna Borough requesting state assistance, and additional reports of storm damage from the Alaska Department of Transportation and Public Facilities, Governor Dunleavy signed an amended disaster declaration on September 11. This amendment added the Matanuska-Susitna, Denali, and North Slope Boroughs, along with the Yukon Flats Regional Educational Attendance Area, to the list of declared state disaster areas
