# **Significant Issues:**

- <u>Elfin Cove</u>: DOT and DGGS sent representatives who arrived today. DOT is assessing damage to the boardwalk while DGGS is assessing the slide area for potential hazards. Debris removal is an ongoing challenge thus this afternoon, the SEOC was informed the community plans to declare a disaster. SEOC will remain in communication and continue to assess any unmet needs.
- Akiak, Mertarvik, Mountain Village and St. Michael: The primary generators in these villages are
  experiencing issues. SEOC will remain in close contact with the communities and AVEC to monitor the
  situation and assess any emerging needs.


