Significant Issues:

- <u>Elfin Cove</u>: Yesterday, Elfin Cove declared a disaster and asked for state assistance. SEOC
 has a Division Supervisor enroute this morning to help support the community. SEOC will
 remain in communication and continue to assess any unmet needs.
- **Akiak:** Alaska Energy Authority arranged for a contractor to assess the broken generators' mechanical issues. He arrived in Akiak yesterday afternoon. SEOC will remain in close contact with the contractor to monitor the situation and assess any emerging needs.
- <u>Buckland:</u> on September 15, the community of Buckland experienced a water pipe failure. SEOC received word from the Northwest Arctic Borough yesterday that the community declared a local disaster and is working directly with the Borough on repairs. The houses that were affected have water, or access to potable water. SEOC will continue to monitor the situation and standby to assist if asked. No request for state assistance currently.
