**Significant Issues:**

**Elfin Cove:**

The Governor has declared a state disaster for the Hoonah-Angoon Census Area, including the community of Elfin Cove, following the major landslides that severely impacted the area earlier this week. The SEOC has deployed a Division Supervisor, who arrived in Elfin Cove to assess damage and identify needs. Additional staff are prepared to mobilize if required, and the SEOC will maintain ongoing communication with local officials.

Prince of Wales Island, Admiralty Island, the City and Borough of Sitka, and the Ketchikan Gateway Borough including Annette Island. Wind gusts may exceed 80 mph at higher elevation sites on Annette Island. The SEOC is closely monitoring the situation and remains in communication with affected communities.

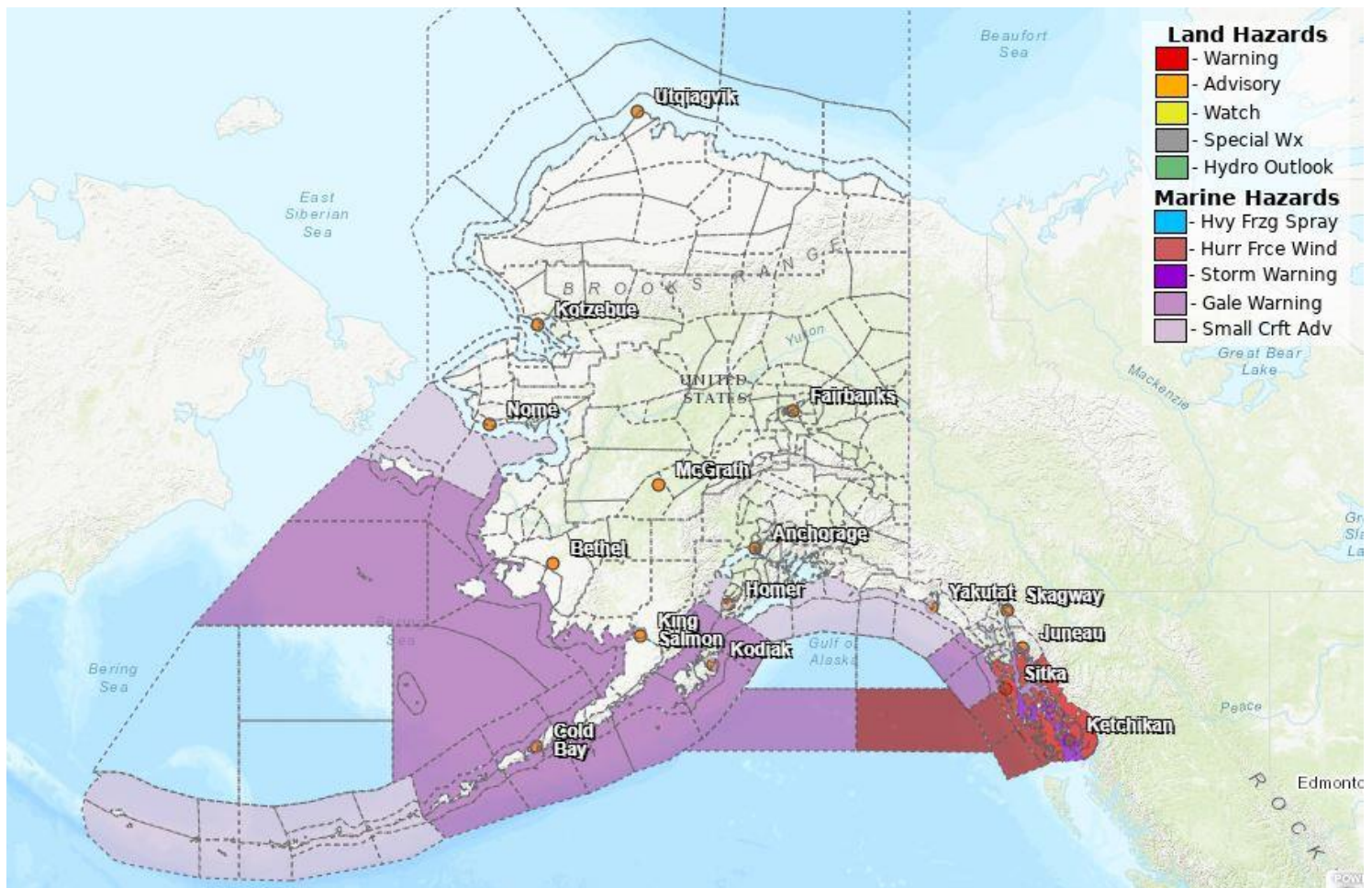
