Significant Issues:

Elfin Cove:

The Governor has declared a state disaster for the Hoonah-Angoon Census Area, including the community of Elfin Cove, following the major landslides that severely impacted the area earlier last week. The SEOC has deployed a Division Supervisor and is engaged with local authorities in recovering from impacts to infrastructure.

- This afternoon a crew of 21 firefighters from the Division of Forestry will be arriving to assist with tree removal and debris management. The crew also brings supplies to support residents with mitigation to damaged homes.
- FirstNet, managed by AT&T, will be deploying a mobile site to support communication infrastructure, this is scheduled to be arriving today as well.
- Alaska Commercial Company Lakeside Grocery Store in Sitka has donated two pallets of food to be delivered today to support the fire crews for the duration of their deployment.

High Wind Warning:

The SEOC and NWS tracked a storm with hurricane force winds that made landfall on Baranoff Island on Friday afternoon. Impacted communities have reported minimal to no damage having made appropriate preparations.

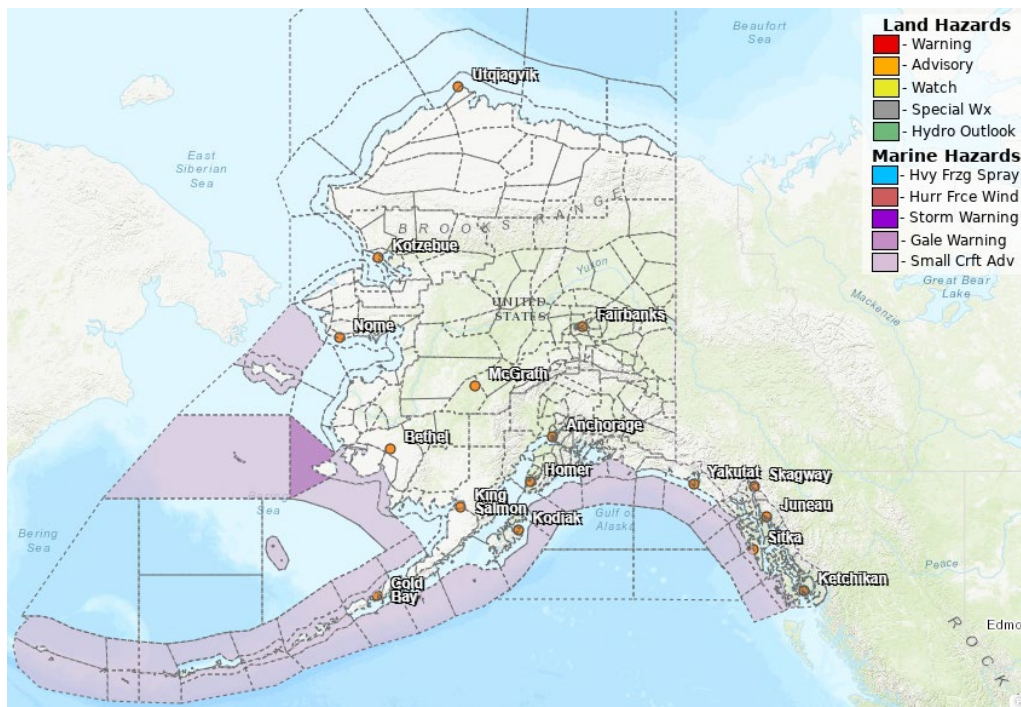
