### **Significant Issues:**

### **Elfin Cove:**

Division of Forestry and DOT&PF crews continue to clear boardwalks from fallen trees and debris. DOT&PF expect to receive a shipment of lumber to rebuild damaged sections later today. Yesterday, the community organized for a fully-engaged cleanup of residential and public spaces. SEOC Div Sup continues to coordinate with local authorities on logistical needs for managing hazards from damaged fuel lines and unstable trees/root mass.

### **UAF Bomb Threat:**

Notification was made to the SEOC of a bomb threat on the UAF campus, causing a partial closure of campus. The SEOC engaged the FBI, Alaska State Troopers, Fairbanks North Star Borough Emergency Management and Mayor. The bomb threat was found to be unwarranted and campus reopened early afternoon.

### Akiak:

Yesterday, the SEOC received a declaration of disaster from Akiak regarding ongoing power loss. Alaska Energy Authority continues to engage a contractor to source parts to repair non-functional equipment.



Moderate snowfall with accumulations between 4-9 inches possible along the Steese Highway.

Special Weather Statement - Southern Denali Borough; Eastern Alaska Range South of Trims Camp Southern Denali Borough; Eastern Alaska Range South of Trims Camp, in effect from Wednesday afternoon through Thursday evening. Snow beginning later today may lead to mixing and slushy accumulations along the Parks Highway.
