## **Significant Issues:**

## **Elfin Cove:**

Debris operations continued, including sawmill processing, controlled burn activities, staging, and transport by boat to the landfill. Over the weekend, response work was completed and community stabilization achieved. Half of the Forestry crew to demobilize Monday, followed by SEOC Division Supervisor demobilization later this week. The incident is in transition to Recovery.



Northern Denali Borough; Eastern Alaska Range North of Trims Camp – From Tuesday afternoon untell Wednesday evening.
