# **Significant Issues:**

The SEOC remains fully activated at Level 3 as the remnants of Typhoon Halong continue to impact western Alaska. High winds and severe coastal flooding have caused widespread damage across the Yukon–Kuskokwim Delta and surrounding regions.

Governor Dunleavy's disaster declaration, issued October 9, has been expanded to include the Yupitt, Pribilof Islands, and Lower Kuskokwim REAAs. All state recovery programs—Public Assistance, Individual Assistance, and Temporary Housing—are active to support affected communities.

Search and rescue operations are ongoing in Kipnuk and Kwigillingok, with Alaska State Troopers, the Alaska RCC, National Guard, and Coast Guard working jointly. Aircraft are rescuing stranded residents and transporting them to safety. The Bethel Armory has been prepared as a contingency shelter, and the Yukon–Kuskokwim Delta Hospital is ready to receive evacuees needing medical care.

Branch Directors are deployed to Bethel, Nome, and Kotzebue to coordinate the response. The SEOC continues to prioritize life safety, sheltering, and logistics support. Volunteer and faith-based partners are assisting with mass care operations, and mutual aid has been requested through EMAC.

Weather remains a concern with continued winds and flooding potential through tonight. priorities and oversee ongoing response and recovery efforts. Demobilization is tentatively planned for Saturday.


