Governor's Oct 9 disaster declaration expanded to Yupitt, Pribilof Islands, and Lower Kuskokwim REAAs. Public Assistance, Individual Assistance, and Temporary Housing programs are active.

Branch Supervisors in Bethel, Nome, and Kotzebue. SEOC prioritizes life safety, sheltering, and logistics (fuel, generators, medical transport). VOAD/faith partners engaged; EMAC requested for augmentation.

SAR/Life Safety: Operations continue in Kipnuk and Kwigillingok with AST, RCC, the Alaska National Guard, and the U.S. Coast Guard. Air assets are transporting critical commodities and evacuating medical cases. Y-K Delta Hospital is postured to receive patients, and the Bethel Armory is prepared as a contingency shelter. Widespread damage to power distribution and water/wastewater systems and ongoing access constraints persist; temporary generation, shelter and sustained fuel supply for critical facilities remain top priorities.

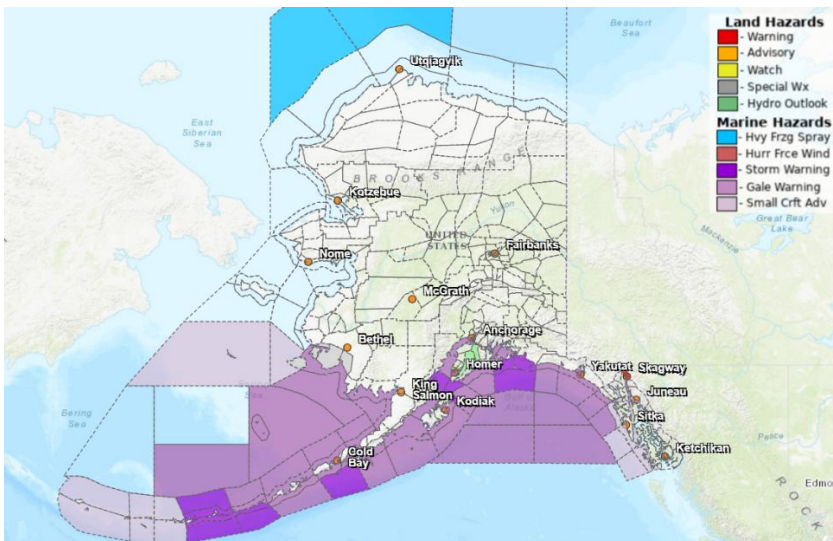
