Recovery efforts continue along the coast, with state and FEMA Joint Command commencing tomorrow Monday Oct 27. Disaster Housing Task Force is close to beginning to move residents from congregate to non-congregate housing.



Special Weather Statement City and Borough of Yakutat; Municipality of Skagway; Haines Borough and Klukwan; Glacier Bay; Eastern Chichagof Island; Cape Fairweather to Lisianski Strait; City and Borough of Sitka; Admiralty Island; City and Borough of Juneau; Petersburg Borough; Western Kupreanof and Kuiu Island; Prince of Wales Island; City and Borough of Wrangell; Ketchikan Gateway Borough; City of Hyder; Annette Island. An active weather pattern returns on Tuesday through the end of the week as multiple, potentially impactful weather systems push into the panhandle. These storms will bring strong winds, elevated seas, and heavy rain to areas along the coast and inner channel communities. More information will become available as forecast confidence increases.
