## Significant Issues:

Typhoon Halong: West Coast Storm: \*See Attachments

**Alaska Volcanoes:** A small explosion from Korovin Volcano was detected in seismic and infrasound data at 9:27 pm AKDT, October 29, 2025. The Aviation Color Code and Alert Level has been raised to YELLOW/ADVISORY.

**Kodiak / Gulf Coast:** SEOC staff contacted Emergency Manager Chief Gonzalez in Kodiak regarding the High Wind Warning. As of 0930 AKDT, Chief Gonzalez reported no wind damage and no 911 activations related to the event. The National Weather Service recorded gusts up to 73 mph in the area, monitoring continues.

**Southeast Region:** Juneau NWS notified SEOC via NAWAS of a Winter Storm Warning, and the Alaska Warning Point was informed. SEOC contacted Skagway Police Department and Haines Police Department for situational awareness. No issues have been reported to SEOC at this time; monitoring continues.


