The Anchorage Multi-Agency Resource Center (MARC) will be open on Friday and Saturday, November 15–16, at the Egan Center from 9:00 a.m. to 6:00 p.m. Mail pick-up services will continue at the Egan Center through the end of November. Bethel DAC has been extended through Friday, November 21. SEOC team members are providing ongoing support at the EOC, Joint Field Office (JFO), and the DACs in Anchorage, Bethel, and Kotzebue.

Emerging Incidents: Bering Sea Storm Forecast

A series of storms is currently moving through the Bering Sea and is expected to continue into early next week, with potential impacts to the Pribilofs, Aleutians, and Southwest Alaska, including strong winds, snow, and possible coastal sea surge.

SEOC is conducting community preparedness calls today based on the most up-to-date National Weather Service forecast. In addition, JFO operations is conducting operational contingency planning in the event these storms disrupt ongoing response and recovery operations.


