Significant Issues: Typhoon Halong: West Coast Storm

Long-term recovery efforts are being managed through a Unified Command, with support from the State Emergency Operations Center (SEOC) and FEMA. Current priorities center on sustaining essential needs, stabilizing communities and survivors, and safeguarding both response personnel and the public.

The State of Alaska has extended the Individual Assistance (IA) registration deadline until January 8, 2026.

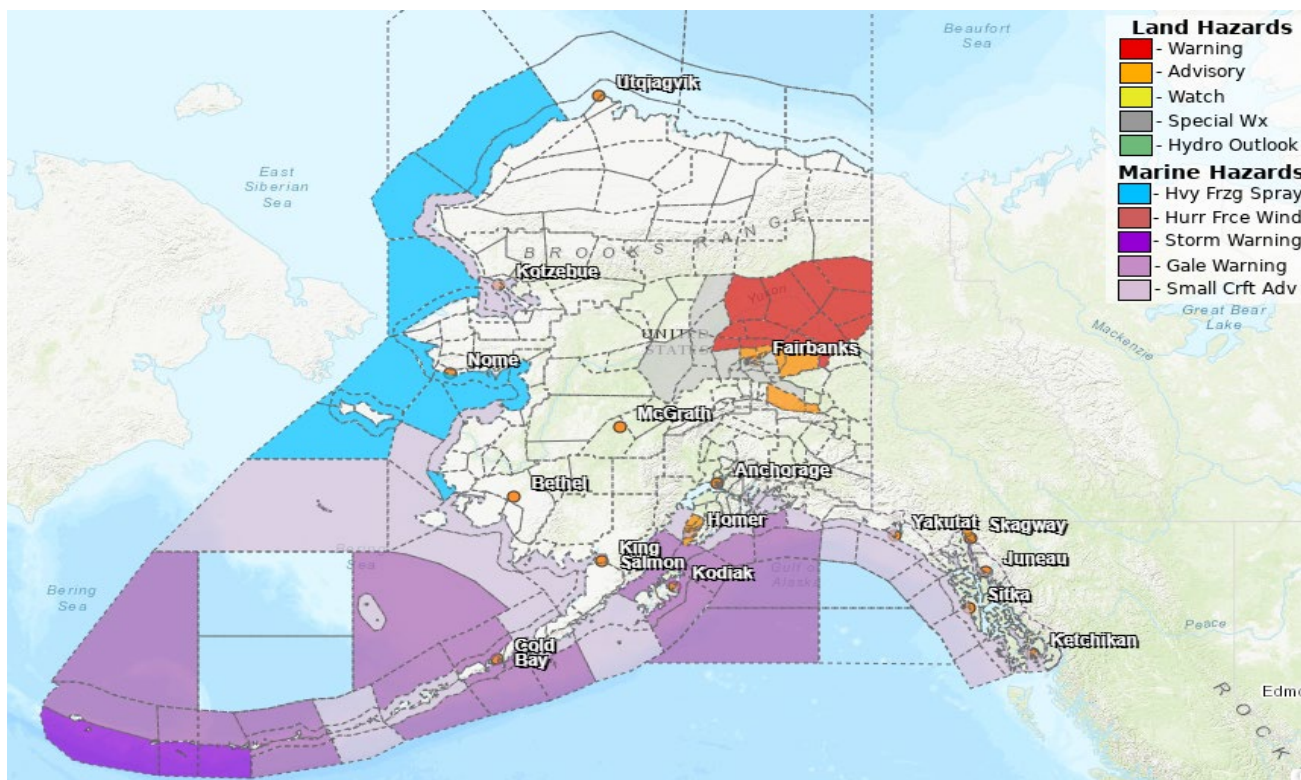
