In Bethel, the Disaster Assistance Center (DAC) and the Yukon–Kuskokwim Emergency Operations Center (YK EOC) have demobilized, and ongoing recovery operations will now be coordinated through the Association of Village Council Presidents (AVCP). As winter conditions allow, AVCP, the AVCP Regional Housing Authority, and the Alaska Department of Transportation and Public Facilities will continue repair and restoration work.


