Significant Issues:

SEOC remains at Preparedness Level 1 - Routine Operations. With the transition of the 2025 October West Coast Storm Disaster to recovery operations coordinated at the Joint Field Office in unified coordination with FEMA, SEOC has shifted to Preparedness Level 1 and is supporting routine monitoring and coordination functions.

Matanuska-Susitna Valley - A cold front over the weekend brought strong winds, with gusts reported over eighty miles per hour, and very cold temperatures. At the height of the storm, more than seventy-one thousand residents were without power for over twenty-four hours. As of this report, more than ten thousand customers remain without power. A shelter managed by the American Red Cross was initially opened at the Glenn Massay Theater on the Mat-Su College campus in Palmer, where four residents and one pet stayed overnight. On Sunday morning shelter operations were moved to the Wasilla Menard Sports Center, where approximately thirty residents were served for warming and dinner and seventeen stayed overnight. Most Mat-Su schools are closed today. Beyond mass care support and coordination, no additional SEOC assistance has been requested at this time.

Yakutat 7.0 Earthquake - On Saturday, December sixth, SEOC received notice of a magnitude seven-point zero earthquake at 1142 hours. No tsunami warning was issued for this event. The earthquake was widely felt in the region, including in Juneau. SEOC executed the Earthquake Checklist and, as of this report, no substantial damages have been reported. Multiple aftershocks occurred, the largest in the magnitude five-point eight range. Haines reported a minor water supply disruption attributed to the earthquake. SEOC will follow up with communities in the affected area today to confirm that no damages were identified during weekend assessments.

Napaskiak - Ice accumulation caused arcing wires and intermittent power disruptions over the weekend. The Alaska Energy Authority and the community were engaged, with power restored and then lost again. SEOC continues to monitor the situation and follow up with local officials.

Akiak Power Disruption - SEOC also received a report of power disruptions in Akiak on Sunday. SEOC engaged the Alaska Energy Authority and continues to follow up with the community regarding restoration status and any unmet needs.

Hokkaido 7.6 Earthquake - This morning at 0515 Alaska Standard Time, SEOC received a report of a magnitude seven-point six earthquake off the coast of Hokkaido, Japan. The event generated a tsunami of approximately zero point four to zero point five feet for Japan, and a tsunami alert was issued there. No tsunami warning or advisory was issued for Alaska, and there are no anticipated impacts to Alaska from this event.


Avalanche Hazards:
