**Significant Issues:**

**State Disaster Declaration – Matanuska-Susitna Borough**

In response to a local disaster declaration from the Matanuska-Susitna Borough, Governor Dunleavy declared a state disaster emergency last night for the Borough, including the cities of Palmer and Houston. This action follows multiple days of high winds, cold temperatures, widespread power outages, and shelter operations within the Borough. The State Emergency Operations Center has been in active communication with the Borough and mass care partners throughout the event. As of this report, nearly all power has been restored in the Borough, and the shelter was maintained in a standby status last night as a contingency.

**Napaskiak Power Disruption**

In Napaskiak, Alaska Energy Authority contract staff arrived in the community yesterday to support restoration of community power. Yukon-Kuskokwim Health Corporation staff plan to travel to the community today to assess potential freeze damage to water infrastructure. The SEOC continues to follow up with local officials and partners as restoration and assessment activities proceed.

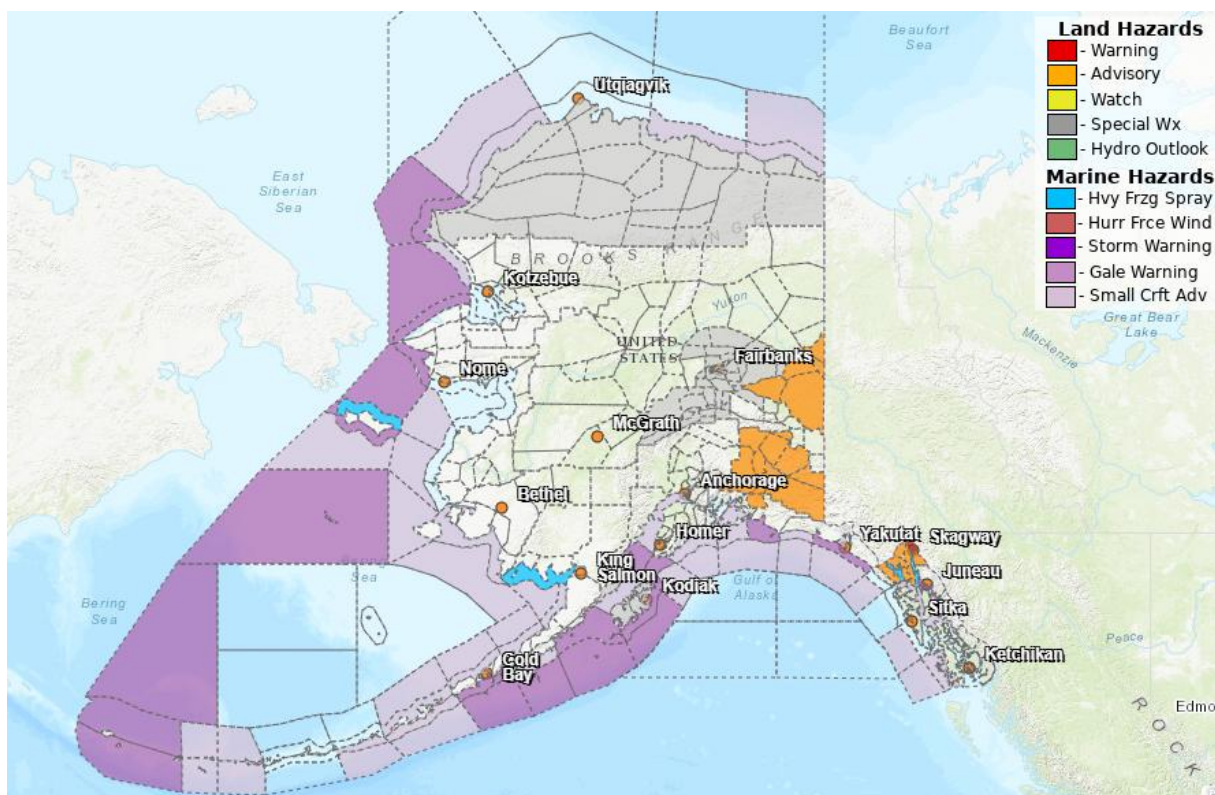

**Kodiak Island Northeast and Kodiak Island Southwest:** Resuspended ash from Katmai–Novarupta expected over Kodiak Island through this evening.

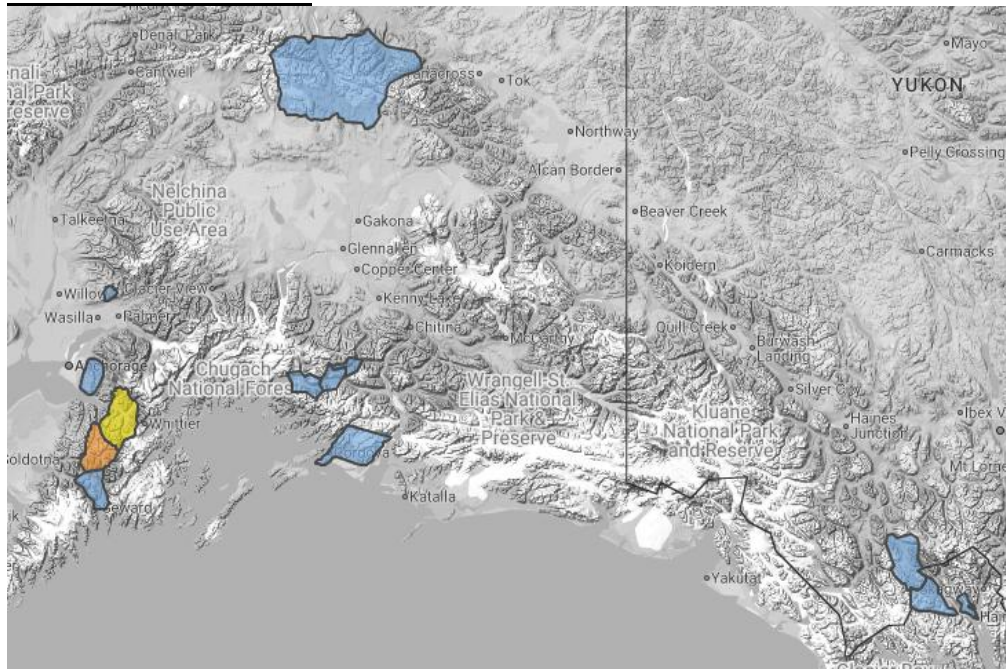
