## Napaskiak Power and Water Disruption

Power has been restored, and damage assessment is ongoing to establish scope of impacts to water generation and community following an impactful ice storm and widespread loss of power. The SEOC remains in close contact with local officials and partners as restoration and assessment activities proceed.



## Significant Weather:



Winter Storm Watch – **Eastern Beaufort Sea Coast**, Tuesday afternoon through Wednesday Afternoon. Blizzard Conditions possible, wind gusts as high as 55 mph.

Special Weather Statement – **Bering Strait Coast, Southern Seward Peninsula Coast**, freezing drizzle possible Monday morning with accumulation.

Winter Weather Advisory – **Eastern Alaska Range south of Trims Camp**, until 9 PM this evening. Blowing snow with very low visibility, gusts as high as 50 mph, wind chills as low as 55 below zero F.

High Wind Warning – **Thompson Pass, Valdez**, until noon AKST today. High winds, strong gusts and significant wind chills.

High Wind Warning – Lower Matanuska Valley, Sutton/Upper Matanuska Valley, Anchorage, until noon AKST today. High winds, strong gusts and significant wind chills.


Wind Advisory – **NW Kenai Peninsula**, until noon AKST today. Gusty winds close to Cook Inlet.

Cold Weather Advisory – **Klondike Highway, near White Pass**, until 6 AM AKST Weds. Dangerously cold wind chills, as low as 35 below zero F.

Winter Storm Warning and Advisory – **Southern Panhandle of Alaska**, a long duration snow event is ongoing with the next band of snow arriving soon and could extend into the early work week. See **Juneau Forecast Office** for more details.

## Avalanche Hazards:



**Hatcher Pass – Low** at mid and upper elevations on all aspects

**Chugach State Park –** Beware wind-loaded terrain, forecast discussion available here.

**Turnagain Pass and Girdwood – Moderate** above 2,500' **Moderate** above 1,000, **Low** below tree line.

**Summit Lake – Moderate** above 2,500; **Moderate** between 1,000-2,500; **Low** below 1,000. **Seward and Lost Lake –** Early season conditions persist, forecasts will be issued when coverage improves.

Valdez Maritime, Intermountain, and Continental – Moderate at all elevation levels.
