#### Significant Issues:

#### West Coast Blizzard:

Blizzard conditions and cold weather impacts caused intermittent power generation issues in Kwigillingok, Kongiganak, and Quinhagak. SEOC is working with AEA to support these communities.

#### **Southeast Storms:**

Over the weekend a storm brought heavy snow to Southeast and will last through Monday. Impacts include snow loading weight, minor flooding, and heavy water runoff, with possibility for freezing rain. Landslide and avalanche risk increase as well. SEOC will maintain contact with communities to determine impacts.

#### Matanuska-Susitna Windstorm:

Another round of strong, gusty winds impacted the Matanuska Valley starting last Saturday afternoon and will continue through Monday evening. Northeast winds are 40-50mph with gusts up to 80 mph and continue to cause power outages and debris damage. Damage assessments will be conducted when windstorm diminishes. SEOC in regular contact with the Mat-Su Borough.

#### **Unalaska Blizzard:**

Unalaska's recent blizzard caused the airport runway to be shut down this morning due to damage from the storm. SEOC is in contact with City of Unalaska and DOT to assess damage and to assist with any unmet needs.



#### Flood Advisory in effect:


- Prince of Wales Island- until 2pm this afternoon
