**Significant Issues:**

**2025 Riverwatch Operations:**

**Lower Yukon Division: Based out of Bethel**

Late yesterday, Division flew the Lower Yukon and landed in Russian Mission to brief community on conditions. Division then flew to Marshal to confirm reports that “2 missing kayakers” were safe and no rescue was needed. Division also met with Marshal tribal leaders. Division then flew to area of Pilot Station, St. Mary’s, Mountain Village, to assess river conditions. Division then flew the Johnson River to assess conditions around Kasigluk, Nunapitchuk, and Atmauthluak where water was high around some properties. Division returned to Bethel and contacted the Johnson River communities who all reported high water impacting boardwalks but no substantial residential or critical infrastructure flooding.

Today Division plans to recheck the Johnson River communities and travel as far as Emmonak at the mouth to check ice conditions.

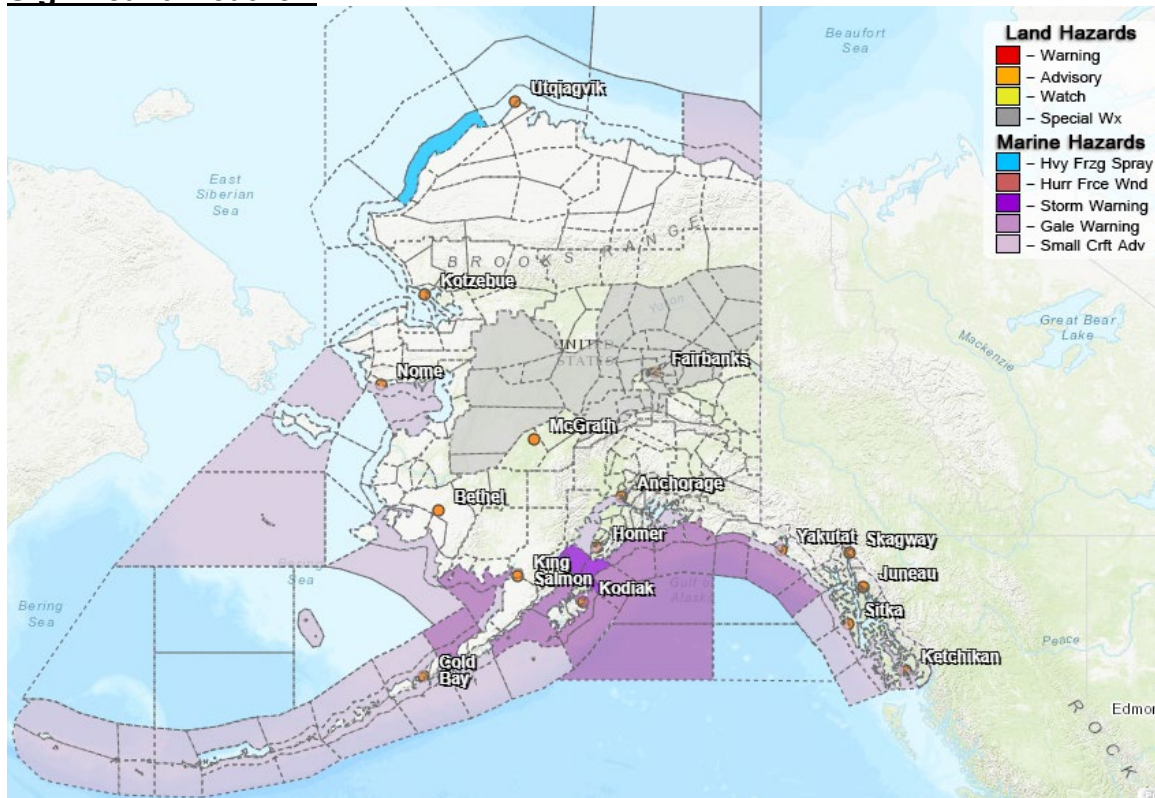
