Significant Issues:

2025 Riverwatch Operations:

Lower Yukon Division: *Based out of Bethel*

Yesterday the Division flew first to check on at risk communities around the Johnson River, landing in Atmaultluk where minor flooding was observed. Division then flew around Kasigluk and landed in Nunapitchuk and met with the community to brief. The team flew next to the area around Long Lake and Mountain Village and landed in Alakanuk to brief the community. Then flew to Nunam Iqua and met with the mayor. Upon departure, checked the mouth of the Yukon into the Bering Sea and returned to Bethel.

The plan for today is to fly to Emmonak. Given the ice conditions and flood risk, operational planning is underway to demobilize the Division.




