Significant Issues:

2025 Riverwatch Operations:

Lower Yukon Division: Based out of Bethel

Yesterday the Division flew first to the communities along the Johnson River that had high water over the last few days. No additional flooding was noted. The Division noted an apparent abandoned fuel drum spill in Kasigluk from the air. Community was notified, absorbent pads were deployed and ADEC notified. The division then flew over Mt. Village and landed in Emmonak and met with community leaders. Took two community leaders up in the air for a local reconnaissance, and checked down into the river mouth and Bering Sea, before returning to Emmonak. No serious flood risk was noted for Emmonak, Alakanuk, or Nunam Iqua and sea ice is less than previous years. Departed Emmonak and flew to Mt. Village where the Division landed and briefed community leaders and local search and rescue team and assessed atrisk location along the river, no flood risk was noted. Departed Mt. Village and landed in St. Mary's to brief, then returned to Bethel.

This morning the Division conducted an interview on KYUK radio in Bethel and will demobilize this afternoon due to location of ice front and reduced ongoing ice jam flood risk on the Yukon River.


