## **Significant Issues:**

### **Juneau Winter Storms:**

The Juneau area has had unprecedented amounts of snow and rainfall over the past several weeks resulting in a heavy burden on local public works, transportation, infrastructure and the community. City and Borough of Juneau and Tlingit & Haida joined forces and established a unified command this weekend to mitigate the ongoing threat. The SEOC, along with several state and private partners, have been attending daily briefs for coordination and have kept in constant communication and will standby to offer any assistance necessary.

### **Statewide Weather Impacts:**

Weather systems throughout the state continue to negatively affect communities. SEOC is actively monitoring the situation and available to support as needed. See weather section below for more information.

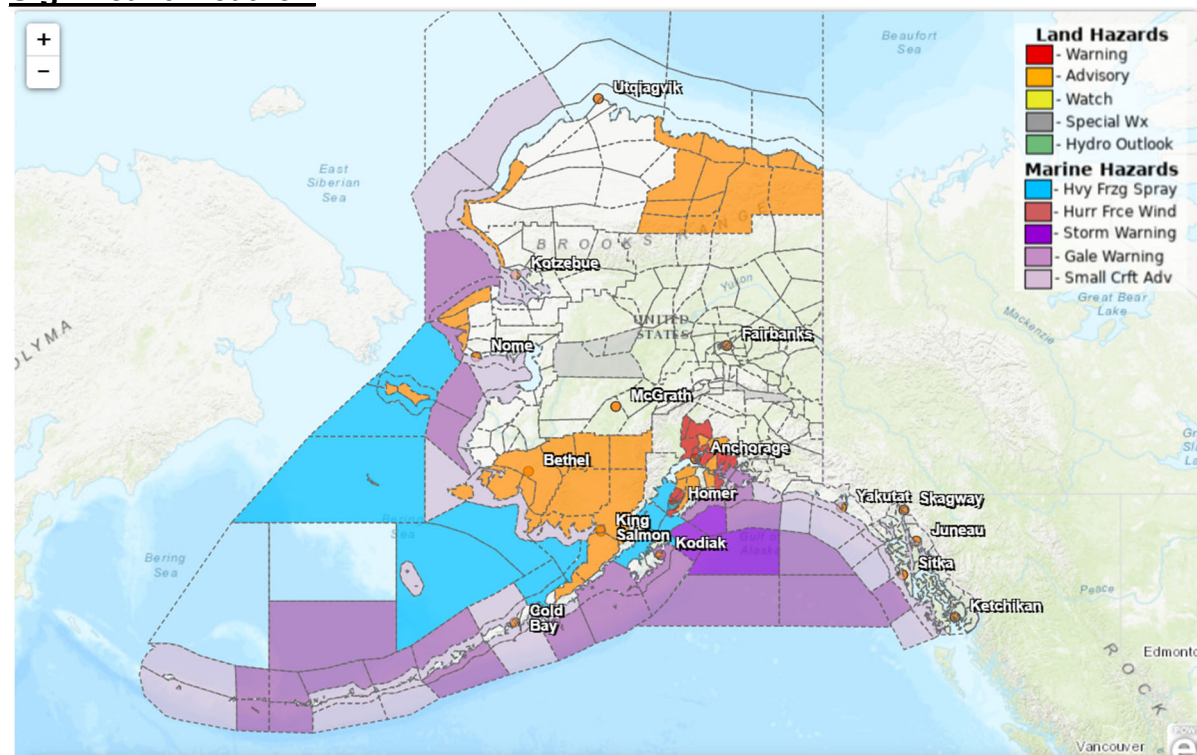

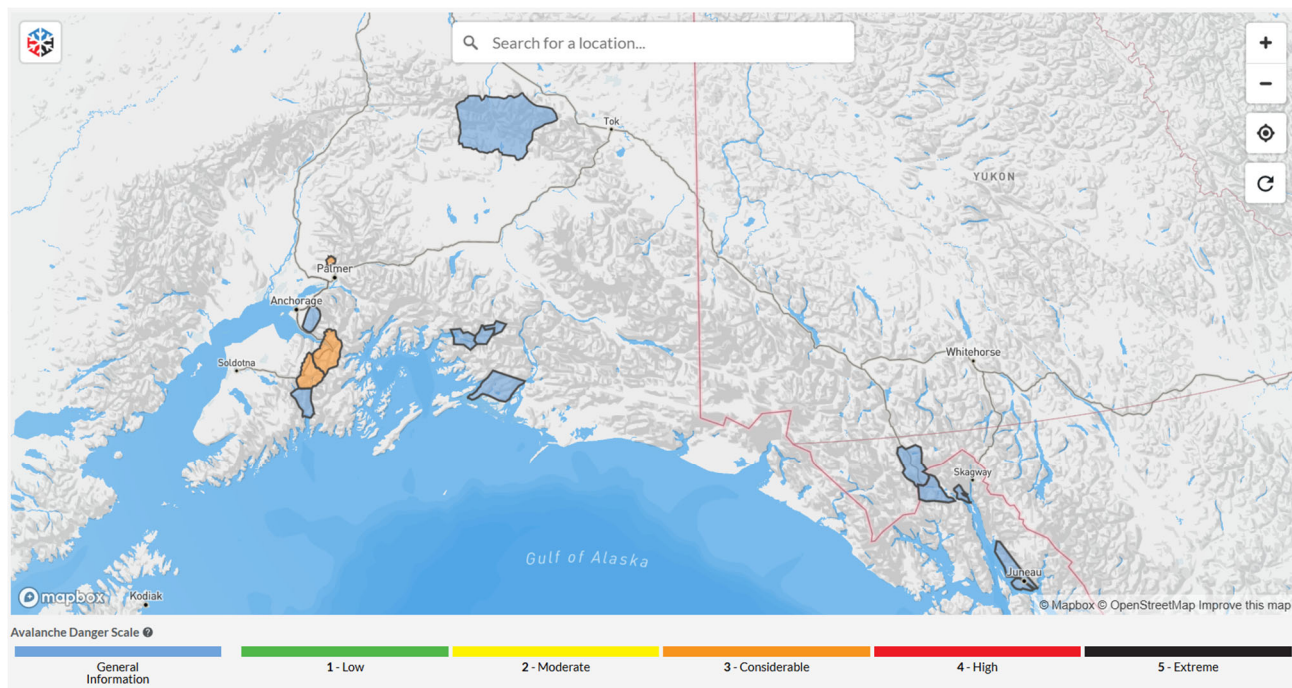
