



**Hatcher Pass** – Low below 2500', Moderate above 2500'

**Chugach State Park** – No rating

**Turnagain Pass and Girdwood** – Considerable at all elevations

**Summit Lake** - Considerable at all elevations

**Seward and Lost Lake**- Considerable at all elevations

**Maritime** – Low below 1,500', Considerable 1,500'-3,000'. Moderate above 3,000'

**Intermountain** – Low below 2000', Considerable above 2,000', Moderate above 4,000'

**Continental** – Low below 2000', Considerable above 2,000'

**Haines: Chilkat Pass, Transitional, Lutak** – High at all elevations

**Juneau: Douglas Island** – No rating

**Chilkat Pass**- No rating

**Transitional**- No rating
