

Blizzard Warning in effect for:


- Western Arctic Coast until noon today

Turnagain Pass and Girdwood – High at elevations above 1000ft, Considerable below 1000ft

Summit Lake - Considerable at elevations above 1000ft, Moderate below 1000ft

Seward and Lost Lake - High at elevations above 1000ft, Considerable below 1000ft

Maritime – Considerable at all elevations

Intermountain – Considerable at all elevations

Continental – Considerable at all elevations

Hatcher Pass – Considerable at elevations above 3500ft, moderate between 2500-3500ft
