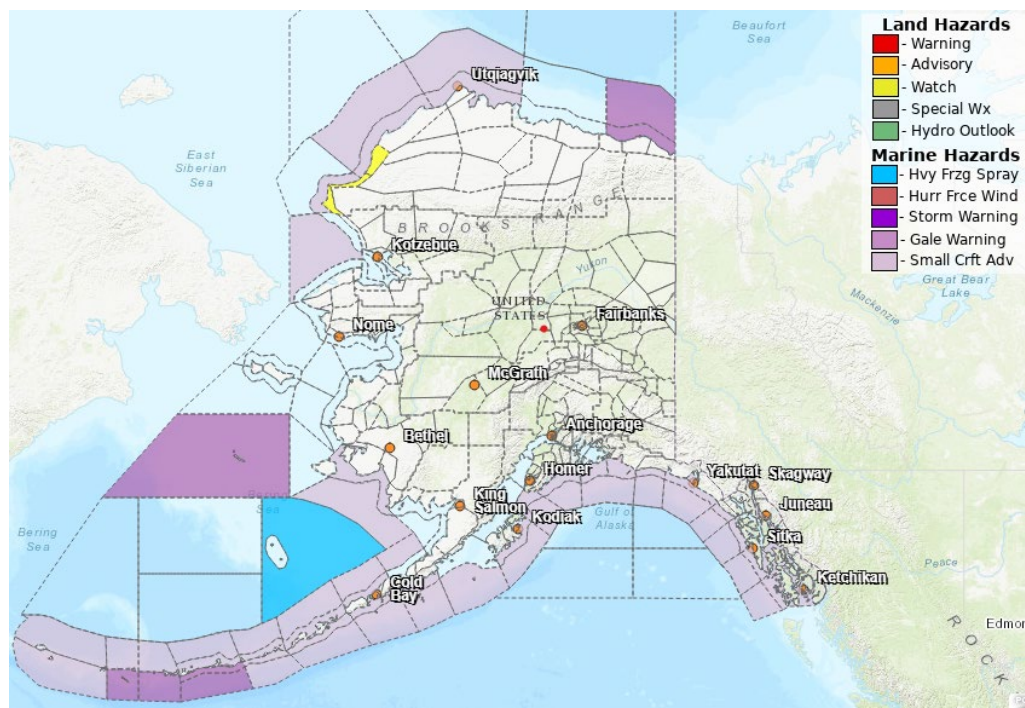

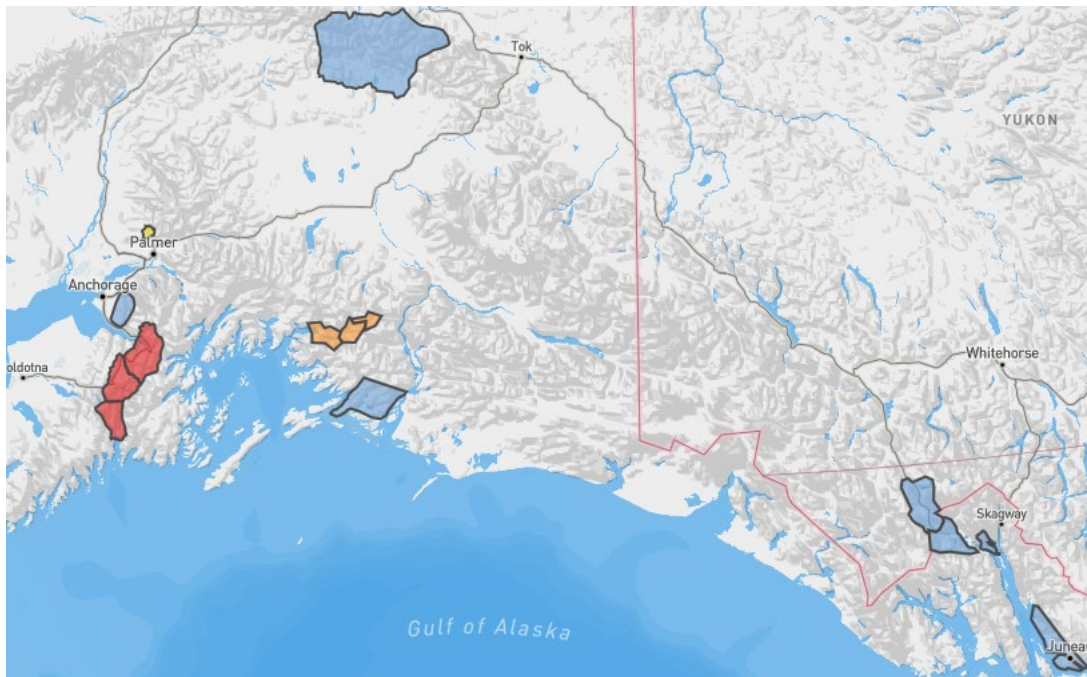
Significant Weather:

Avalanche Conditions:



Hatcher Pass – Low below 2500'; Moderate above 2,500'; Moderate above 3,500'

Chugach State Park – Dangerous avalanche conditions exist, travel in avalanche terrain is not recommended

Turnagain Pass and Girdwood – Considerable below treeline; Considerable between 1000'-2500'; High above 2,500

Summit Lake – Considerable below treeline; Considerable between 1000'-2500'; High above 2,500

Seward and Lost Lake – Considerable below treeline; Considerable between 1000'-2500'; High above 2,500

Maritime; Intermountain; Continental – Considerable at all elevations

Haines – Wind slabs may be present, deeper weak layers remain a concern.

Juneau – Low at all elevations
