

WARNINGS:

Blizzard Warning for Western Arctic Coast remains in effect until 3 PM AKST Wed Feb 4.

WATCHES:

High Wind Watch for Kodiak Island (northeast; including Port Lions, Kodiak City, and Ouzinkie) remains in effect late tonight (Mon night Feb 2) through Tue morning Feb 3.

Winter Storm Watch for the Dalton Highway, Elliott Highway, and Steese Highway summits (White Mountains / high terrain south of the Yukon River) is now in effect Tue morning Feb 3 through late Wed night Feb 4.

ADVISORIES:

Winter Weather Advisory for the Northwest Arctic Coast, Northern Arctic Coast, Central Beaufort Sea Coast, and Eastern Beaufort Sea Coast remains in effect until 3 PM AKST Wed Feb 4.

SPECIAL WEATHER STATEMENT:

Prince of Wales Island; Ketchikan Gateway Borough; Annette Island – Monday night through Wednesday morning.

Avalanche Conditions:

Hatcher Pass – Low below 3500'; Moderate above 3,500'

Chugach State Park – Dangerous avalanche conditions exist, travel in avalanche terrain is not recommended.

Turnagain Pass and Girdwood – Considerable above 1000'-2500'; Moderate below 1000'

Summit Lake – Moderate below treeline; Considerable between 1000'-2500'

Seward and Lost Lake – Moderate below treeline; Considerable between 1000'-2500'

Maritime; Intermountain; Continental – Moderate below 2000' Considerable above 2500'

Haines – Wind slabs may be present, deeper weak layers remain a concern.
