Barry Arm Landslide / Tsunami Risk:

The Barry Arm landslide currently shows no signs of large-scale active deformation but smaller-scale instabilities on the surface of the landslide still pose a threat of localized tsunami generation in Barry Arm. Mariners transiting near Barry Arm should remain vigilant.



WARNINGS:

Blizzard Warning for Kuskokwim Delta Coast and Nunivak Island is in effect from 1 AM Tuesday to 3 AM AKST Wednesday.

Winter Storm Warning for Western Capes and Northern Bristol Bay Coast remains in effect from 3 AM Tuesday to 3 AM AKST Wednesday.

Interior Kuskokwim Delta remains in effect from 3 AM Tuesday to 3 AM AKST Wednesday.

Extreme Cold Warning for Western Arctic Coast, Northwest Arctic Coast, Northern Arctic Coast, Central Beaufort Sea Coast, Eastern Beaufort Sea Coast, Western Arctic Plains, Howard Pass and the Delong Mountains, Central Arctic Plains, Central Brooks Range, and Romanzof Mountains is in effect until 6 PM AKST Wednesday.

South Slopes of the Eastern Brooks Range is in effect until 6 AM AKST Wednesday.

High Wind Warning for Central Aleutians remains in effect until noon AKST Tuesday.

WATCHES:

Winter Storm Watch for Shishmaref, Bering Strait Coast, Southern Seward Peninsula Coast, and Interior Seward Peninsula is in effect from Tuesday morning through Thursday morning. Eastern Norton Sound and Nulato Hills, Yukon Delta Coast, and Lower Yukon River is in effect from late Monday night through late Wednesday night. St. Lawrence Island is in effect from late Monday night through late Wednesday night.

High Wind Watch for Municipality of Skagway remains in effect from Tuesday evening to late Tuesday night.

ADVISORIES:

Winter Weather Advisory for Central Copper Valley, Southern Copper Valley, Tok Cutoff, and McCarthy remains in effect until 6 PM AKST this evening.

Winter Weather Advisory for Pribilof Islands remains in effect from 6 PM this evening to 9 PM AKST Tuesday.

Upper Tanana Valley is in effect until 9 PM AKST Monday.

Cold Weather Advisory for Yukon Flats is in effect until 6 AM AKST Wednesday.

Wind Advisory for Eastern Aleutians is in effect from 3 PM this afternoon to 9 PM AKST Tuesday.

ALERTS:

Special Weather Statement for City and Borough of Yakutat, Haines Borough and Klukwan, Glacier Bay, Eastern Chichagof Island, Cape Fairweather to Lisianski Strait, City and Borough of Sitka, Admiralty Island, City and Borough of Juneau, Petersburg Borough, Western Kupreanof and Kuiu Island, Prince of Wales Island, City and Borough of Wrangell, Ketchikan Gateway Borough, City of Hyder, and Annette Island highlights a strong front and gale to storm force low bringing impactful weather Tuesday through Thursday.

Avalanche Conditions:



Hatcher Pass – Low below 2500'; Moderate above 2,500'

Chugach State Park – Use conservative travel protocols—move one at a time and watch your partners from safe spots outside of avalanche runout zones.

Turnagain Pass and Girdwood – Moderate above 2500' Low below 2500".

Summit Lake – Considerable above 2500' Moderate 100' – 2500' Low below treeline.

Seward and Lost Lake – Considerable above 2500' Moderate above 1,000' Low below treeline.

Maritime - Considerable at all elevations.

Intermountain - Considerable at all elevations.

Continental – Considerable at all elevations.

Haines – Wind-drifted snow at upper elevations and buried surface hoar continue to pose concerns. Favor low-angle terrain, reduce exposure, and think carefully about the consequences of overhead or connected terrain.
