Significant Issues:

The SEOC is monitoring the GLOF situation in Juneau for elevated risk of flooding along the Mendenhall River. Suicide Basin is confirmed to be full as of this morning showing signs of overtopping with an anticipated release anytime in the next 0 to 6 days.

The SEOC has deployed a Juneau Response Operations Section Chief, Division Supervisor and Public Information Officer to Juneau to directly coordinate with the CBJ/Tlingit-Haida Unified Command.
