# **Significant Issues**

## **Matanuska River Erosion:**

DOT/PF advised SEOC of ongoing erosion on Glenn Hwy milepost 63 from the Matanuska River. This is an ongoing/historical erosion issue. SEOC contacted National Weather Service and while rain is in the forecast, no substantial flooding is expected. SEOC forwarded DOT/PF information to Mat-Su Borough Emergency Management.

# **Clark's Point Water System Issues:**

Clark's Point Tribal Administrator contacted SEOC today about issues with their water system. The city purchased and installed a new water pump but a well collapse, and resulting water pump triggered power failure, has caused very limited water production. SEOC contacted ADEC who advised that Village Safe Water was actively engaged, along with Bristol Bay Health Corporation in repairing the system issues. Bottled water was shipped to the community and distributed. A boil water notice is in effect.

The Riley Fire in Denali National Park and Preserve was reported to be 25% contained by Tuesday evening. Power has been temporarily restored to those affected by the fire for the evening. The line will be deenergized, and power will go out at 8 a.m. to allow fire crews safe access. This pattern will continue until the fire is substantially contained, providing power in the evening, and turning it off during the day while crews are on the ground.

Denali National Park tour and transit bus service will remain suspended on Wednesday. A team from the Red Cross and the Salvation Army have established the Tri-Valley School in Healy as an evacuation location for anyone needing shelter and support. Park campgrounds will close at 11:00am on Wednesday.

Globe Fire #253 (Grapefruit Complex):

- Go- Red: Elliott Highway Milepost 30-65
- Set- Yellow Milepost 65-70
- Ready-Green: Milepost 18-30

#### Riley Creek Fire #318 (Denali):

- Go- Red: All Bison Gulch and Antler Ridge hikers, Riley Creek Campground and all employees housed at the Denali National Park Joint Venture facility. ANYONE IN RED AREAS SHOULD EVACUATE.
- Set- Yellow: There are currently no locations in "set".
- Ready-Green: The Nenana Canyon area (aka Glitter Gulch), Denali National Park Headquarters, C-Camp. Stay alert and monitor for evacuation status updates.

# Montana Creek Fire #312 (Mat-Su Valley):

- Go- Red: None
- Set- Yellow Residences on Leroy Davie and Riddle Ave subdivisions.
- Ready-Green: None

# McDonald Fire #119 (Fairbanks North Star Borough):

- Go- Red: None
- Set- Yellow Cabins in Tanana South area.
- Ready-Green: Areas along the Salcha River, Harding Lake, Hollies Acres, Canaday, Salcha and Johnson Road neighborhoods.


