Significant Issues:

Homer Spit Storm:

On November 16-17, 2024, a storm with strong winds caused wave damage to the Homer Spit and in Ninilchik. Late Monday, the City of Homer declared a local disaster in response to the storm. SEOC has received initial storm road damage information from the Alaska Department of Transportation and Public Facilities.

SEOC is deploying a Division Supervisor to Homer today to work with the Kenai Peninsula Borough and City of Homer to gather storm damage impacts. There are no reports of injuries from this incident.

Point Hope Power Outage:

Iñupiat Community of the Arctic Slope advised SEOC of a power failure in Point Hope yesterday morning. The North Slope Borough will fly in a lineman to address the power issue to the community. The Point Hope School continues to remain open for sheltering if needed. SEOC will continue to monitor the situation and be in contact with the North Slope Borough.


