**Significant Issues:**

**State at Fire Preparedness Level 4**

Red Flag Warnings in effect for most of Interior Alaska, with ongoing hot and dry weather. Increased fire behavior and new ignitions are possible from Denali north today through the holiday weekend.

Key concerns regarding the holiday weekend are the impacts to Parks Highway from two different large fires and additional evacuations for fires anywhere in the state. Currently Parks Highway has temporary roadway closures from MP-341 to MP-315 between Nenana and Fairbanks due to fire activity.

SEOC will have multiple staff available over the Independence Day holiday weekend to support Alaska Division of Forestry and Fire Protection and local communities.

SEOC continues to implement Governor Dunleavy's declaration of disaster for the Denali Borough, with a focus on providing disaster Individual Assistance to Borough residents who lost their homes in fires.

**Alert:** Nebesna Road-Flooding from MP 20 to end of road. Travel NOT recommended.

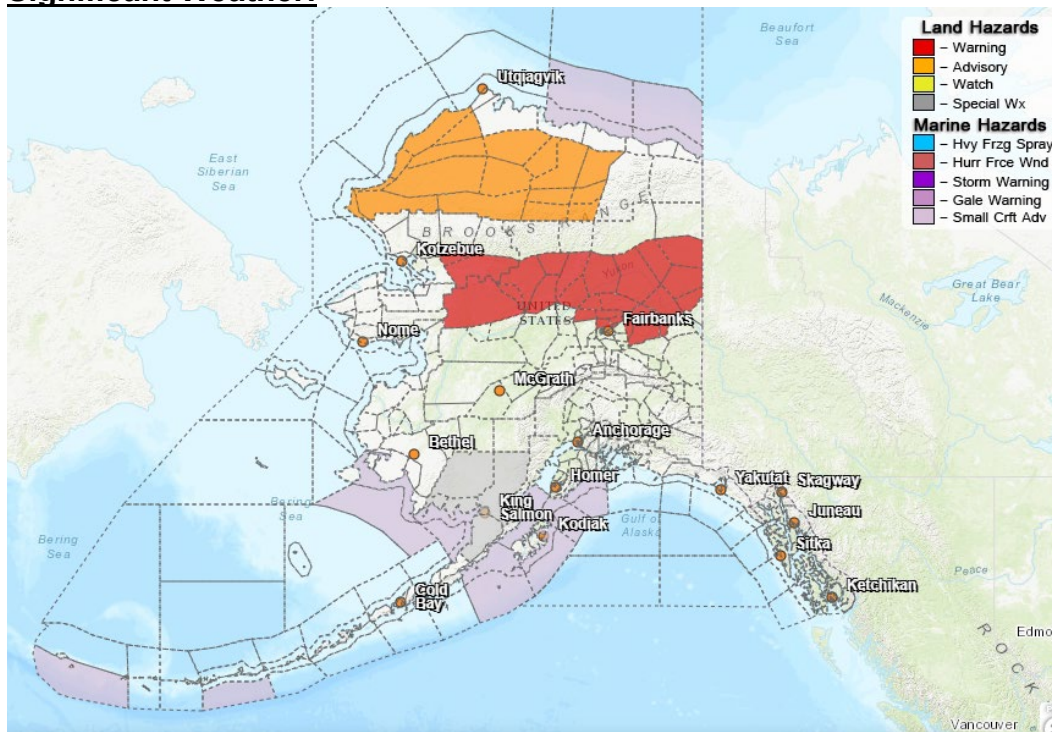

**Red Flag Warning:**

**Upper Koyukuk Valley; Dalton Highway Summits; Yukon Flats; White Mountains and High Terrain South of the Yukon River; Upper Chena River Valley; Chatanika River Valley**-red flag warning remains in effect until 10pm this evening.

**Upper Kobuk Valleys; Lower Koyukuk Valley**-in effect until 10pm this evening.

**Heat Advisory:**

**Western Arctic Coast; Northwest Arctic Coast; Western Arctic Plains; Howard Pass and the Delong Mountains; Central Arctic Plains; Central Brooks Range**-remains in effect until 10pm Saturday.

**Hydrologic Outlook:**

**Northern Alaska Peninsula; Bristol Bay Borough (Naknek and King Salmon); Northern Bristol Bay Coast; Inland Bristol Bay; Lake Iliamna / Nila Vena / Nanvarpak**-high water on area streams and rivers following widespread rain.
