**Significant Issues:**

**Statewide Wildland Fires Response:**

The State Emergency Operations Center (SEOC) continues to implement the Governor's Disaster Declaration for the Denali Borough, supporting the Alaska Division of Forestry and Fire Protection (DOF) in response to ongoing statewide wildland fire activity.

SEOC coordinated with the Fairbanks North Star Borough and Fire Incident Commands yesterday afternoon to issue an additional Wireless Emergency Alert (WEA) GO NOW evacuation order for residents in the Unorganized Borough.

SEOC Division Supervisors for Denali and Fairbanks North Star Borough have been deployed to a public meeting in Ester this evening to support coordination and engagement with impacted residents and local authorities.

The SEOC Mass Care Group continues coordination with the American Red Cross, which is operating shelters for evacuees and providing emergency assistance and cleanup supplies. The Salvation Army is actively supporting response efforts with shelter feeding support, distribution of food boxes, and spiritual care services for displaced individuals.

**Juneau – Glacial Outburst Flood Risk:**

SEOC will conduct a briefing with FEMA today regarding the Glacial Outburst Flood (GLOF) risk in Juneau. Regular coordination calls have been initiated with the City and Borough of Juneau (CBJ) and Tlingit & Haida Unified Command to ensure continued preparedness and operational response planning.


